

Legislative Update

This week on Jones Street the COVID-19 pandemic hung over the General Assembly like a huge rain cloud in an uncertain background. The week began with legislators receiving a revised revenue forecast for the 2019-2021 Biennium, which described the factors that pushed the economy into a recession. Latest projections estimate a revenue shortfall of \$4.2 billion for the biennium. Although lawmakers generated a number of bipartisan bills to help North Carolinians during this critical time, members also continued to battle Governor Cooper over the best way to reopen the state.

On Thursday, the Senate Appropriations/Base Budget committee heard Senate Bill 836, *State Operations/Increase Federal Funds Use*, which provides a \$300 million increase to the original appropriation of \$70 million for the continuity of operations needs across state government. Specifically, this provision applies to overtime costs at prisons, community corrections, juvenile facilities, and veterans homes, to name a few uses.

Moreover, in the House chamber on Thursday, House Bill 1187, *Raise the Age Funding*, which provides funding for additional bed space needed to accommodate the anticipated increase in juveniles resulting from Raise the Age Implementation, unanimously passed the House. It has been sent to the Senate and will be heard in the Appropriations/Base Budget committee. The bill provides an appropriation of \$10,440,000 for renovations at Perquimans Youth Detention Center and C.A. Dillion Youth Development Center and for construction of the new Rockingham County Youth Development Center. Unfortunately, the bill as written directs the funds for these items to be transferred from the Statewide Misdemeanant Confinement Fund.

House Bill 1063, *Fund VIPER Tower Hardware Upgrades*, which directs \$19,800,530 nonrecurring to upgrade remaining Quantar base stations to GTR base stations was unanimously passed during Thursday's voting session. These upgrades are critical to ensuring future interoperable communication between public safety officials and other first responders. Now the bill has been sent to the Senate and will be heard in the Appropriations/Base Budget committee.

Also of note, the 2.5% raises to employees from the various mini budgets passed last year will go into effect on July 1, 2020. Additionally, the Senate Select Committee on Prison Reform will meet next week, on June 2 at 11:00 am. The meeting will feature presentations from vendors who have experience in prison safety technology.
