Data Sources and Definitions FY 2007/08 Data

Arrests for Offenders Under Age 18 at Time of Arrest

- Data provided by the NC State Bureau of Investigation (SBI).
- Based on data collected by law enforcement using the Juvenile Contact Report (for those under age 16) or the Arrest Contact Report (for those age 16 or older).
- Includes arrests for Part I and Part II offenses.
- For simplicity, all contacts are described as "arrests."
- For juveniles, this "arrest" data does not mirror complaints filed against juveniles with the Department of Juvenile Justice and Delinquency Prevention, which includes complaints that originate, for example, from schools, citizens, and parents in addition to those that originate with law enforcement.

Juvenile Justice System: The Processing of Complaints Received in FY 2007/08 with Events Characterized by the Most Serious

- Data provided by the NC Department of Juvenile Justice and Delinquency Prevention (DJJDP) using the North Carolina Juvenile Online Information Network (NC-JOIN).
- Sample Description: Delinquent complaints filed in FY 2007/08 were tracked as they progressed through the system from initial filing to resolution.
- Complaint Event: Most serious complaint for a juvenile on a given day. Juveniles with complaints filed on multiple dates during the FY would be represented in the data multiple times. The most serious information at each point in the process (e.g., complaint, intake decision, court decision, adjudication, disposition) characterizes a complaint event for juveniles with multiple complaints on a single date.
- Includes only delinquent complaints. Excludes undisciplined complaints and cases with a most serious complaint for an infraction.

Criminal Justice System: The Processing of Charges Filed in FY 2007/08 with Events Characterized by the Most Serious

- Data provided by the NC Administrative Office of the Courts (AOC) using the Automated Criminal/Infractions System (ACIS).
- Sample Description: Criminal charges filed in FY 2007/08 were tracked as they progressed through the system from initial filing to resolution.
- Charge Event: Most serious charge for a defendant on a given day. Defendants with charges filed on multiple dates during the FY would be represented in the data multiple times. The most serious information at each point in the process (e.g., charge, method of disposition, conviction, sentence) characterizes a charge event for defendants with multiple charges on a single date.
- Excludes cases with a most serious charge for a traffic offense (including driving while impaired) or for an infraction.
- Excludes data for those age 15 or younger at time of offense (n=100) and for those with missing age values (n=36,270 or 6.6% of total charge events).




The Processing of Complaints Received in FY 2007/08 with Events Characterized by the Most Serious
