Reminder to file your 990!

GIST

Subrecipients that fall under IRS Section 501(c)(3) must file Form 990 by the 15th day of the 5th month after the end of the organization's accounting period. GCC reviews the filings during the grant application process and a failure to submit a current 990 may delay or prevent approval for funding.

Failure to file a 990 for three consecutive years will result in automatically losing tax-exempt status, along with disqualification from receiving GCC funding until reinstated. When automatic revocation takes place, filing a new 990 does not reinstate the organization. The organization must apply to have its non-profit status reinstated and will be issued a new determination letter by the IRS if tax-exempt status is approved. - Prevalence of Drug Offenses in North Carolina, 2019-2022 - 14% of all NIBRS incidents during the four-year period included at least one drug offense.
- North Carolina Statewide Automated Victim Assistance and Notification – More than 40,000 register with SAVAN each month to receive offender notifications and service information.
- Motor Vehicle Theft in North Carolina, 2020-2022 - More than 61,000 vehicles were stolen from 2020-2022 in North Carolina. The state rate of vehicle thefts was lower than the U.S. rate.

- ePass Video: An overview of how to apply online through ePass.
