The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety Juvenile Justice and Delinquency Prevention in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2026-2027 beginning on, or after, July 1, 2026. The use of these funds in this county requires a local match in the amount specified above.

Based on identified needed programs and possible gaps in the service continuum, the following program types will be considered for funding:		
Restitution/Community Service Mentoring Services Parent/ Family Skill Building (provide services to the whole family) Interpersonal Skill Building Vocational Skills/ Development Experiential Skills Building	Temporary Shelter Care Teen Court (including sentencing and responsive circles) Tutoring/ Academic Enhancement Runaway Shelter Care	

Proposed program services should target the following risk factors for delinquency or repeat delinquency:

1) School Behavior Problems 2) Pro-social peer rejection and association with others involved in delinquent activity 3) Parent/Guardians who have difficulty providing adequate supervision 4) Reduction in Juvenile Recidivism, 5) Lack of Job Skills/Vocational Development Skills 6) History of family members involved in criminal justice system

Proposed services should address the following concerns as reported in the Youth Assessment Screening Instrument (YASI) for adjudicated youth:

Peer Domain: Anson County youth involved with juvenile justice system are more likely to be rejected by pro-social peers and regularly associate with others involved in delinquent activities.

Individual Domain: Youth involved with the juvenile justice system have a higher rate at first referral under the age of 12, felony referrals, prior detention admissions.

Family Domain: Court referred youth and family exhibit substance use and criminal history and inadequate supervision. Access services that provide best practices and have the ability to engage families are needed.

School Domain: Youth involved with Anson County juvenile justice system have increased risk of serious school behavior, higher dropout rates, behavioral report filed by school resource officer, in school suspension and out school suspension.

Applicants are being sought that are able to address items below:

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individuals from gang participation.
5. Awareness of and sensitivity to Racial Ethnic Disparity that exists in the County.
6. Programs are encouraged to provide effective programming that includes restorative justice practices.

Only local public agencies, 501c3 non-profit corporations and local housing authorities will be considered for funding.
