The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety Juvenile Justice and Delinquency Prevention in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2026-2027 beginning on, or after, July 1, 2026. The use of these funds in this county requires a local match in the amount specified above.

Based on identified needed programs and possible gaps in the service continuum, the following program types will be considered for funding:		
Restitution/Community Service Mentoring Services Parent/ Family Skill Building (preferred EBP Model) Interpersonal Skill Building (preferred EBP Model) Vocational Skills Experiential Skills	Clinical Skill Assessment Teen Court Tutoring/ Academic Enhancement Substance Abuse Treatment (preferred EBP Model)	Temporary Shelter Care Runaway Shelter Care Temporary Foster Care Juvenile Structured Day

Proposed program services should target the following risk factors for delinquency or repeat delinquency:

- 1) School Behavior Problems and attendance issues, 2) Pro-social peers and association with peers with negative delinquent influence, 3) History of Assaultive Behaviors, 4) Poor Parenting Skills, 5) Reduction in Juvenile Recidivism, 6) Substance Use, 7) Domestic Family Discord or Violence, 8) Mental Health Needs

Proposed services should address the following concerns as reported in the Youth Assessment Screening Instrument (YASI) for adjudicated youth:

Peer Domain: Richmond County youth involved with juvenile justice have friends that have a negative delinquent influence. Richmond County youth involved with juvenile justice lack positive influencing peers that are supportive and do not maintain contact with responsible peers.

Individual Domain: Richmond County youth involved in juvenile justice are aged 12 years or older at the time of the first delinquent referral. Richmond County youth involved with juvenile justice reported having issues with aggression/assaultive behavior. Richmond County youth involved with juvenile justice referrals for person crimes.

Family Domain: Richmond County youth involved with juvenile justice has a family member with a prior criminal history. Richmond County youth involved with juvenile justice with family members whose living arrangements include living with a sibling, relative or other custodian.

School Domain: Richmond County youth involved in juvenile justice reported having 5 or more unexcused absences from school. Richmond County youth involved in juvenile justice reported school conflict in which reports were filed by the SRO. Richmond County youth involved in juvenile justice reported some poor academic performance in school.

Applicants are being sought that are able to address items below:

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individuals from gang participation.
5. Awareness of and sensitivity to Racial Ethnic Disparity that exists in the County.
6. Programs are encouraged to provide effective programming that includes restorative justice practices.

Only local public agencies, 501c3 non-profit corporations and local housing authorities will be considered for funding.
