2022 Applications - VOCA

Limitations for 2022 Applications - VOCA

▶ **Application Submission Limits:**

- Agencies could submit no more than three (3) total competitive applications and
- Only one application per priority.
- Basic services (noncompetitive) priority projects were not included in the total of competitive projects.

▶ **Growth:**

- Agencies requesting funding for continuation projects are limited to 0% growth. This means that an agency applying for a previously GCC funded project could only apply for the same amount of the previously funded project.

Limitations for 2022 Applications - VAWA

▶ Application Submission Limits:

- Agencies could submit one application per VAWA STOP Priority Service Area.
- NOTE: A prosecutorial district is a single subrecipient.

▶ Growth:

- Agencies requesting funding for continuation projects in the Victim Services and Discretionary priorities were limited to 0% growth. This means that an agency applying for a previously GCC funded project could only apply for the same amount of the previously funded project.
