Multipurpose Juvenile Home and Transitional Living Programs

#### Multipurpose Juvenile Homes

- Established in 1993
  - Aimed at reducing detention rates as well as YDC commitments
- > Developed in predominantly rural areas to serve local judicial districts
- Serve High Risk Level 2 youth as well as Level 3 step down
- Serve males and females ages 10-17

#### Locations

- Chowan County (Edenton)
  - Serves Districts 1 and 2
- Hertford County (Winton)
  - Serves Districts 6, 3 and 7
- Macon County (Franklin)
  - Serves Districts 24, 27 and 30
- Robeson County (Lumberton)
  - Serves District 16
- Wayne County (Goldsboro)
  - Serves District 8

- Assessment
- Evidenced Based Cognitive Behavioral Model
- Social Skills training
- Life Skills
- Education
- Family Services
- Aftercare (6 months)
- College/Trade school scholarships w/ mentors

Maintaining a positive on-going relationship with a caring, responsible adult	89%

Following substance abuse recovery plan	68%
Regularly participating in pro-social community activities	76%

- Craven Transitional Living Program
  - Established in 2011
  - Serves Males ages 16-18
  - Serves youth statewide
  - Located in Craven County (New Bern)



### North Hills Transitional Living Program

- Established in 2014
- Serves females ages 16-18
- Serves youth statewide
- Located in Raleigh



### **Program Components**

- Evidenced based cognitive behavioral model
- Social skills training
- Independent Living skills
- Education
- Casey Life skills assessment and training
- Vocational assessment and training
- CANS
- Community access and support
- Aftercare (six months)
- Higher Education support and scholarship

### 2013-2014 Education Outcomes

#### CRAVEN

- 61% GED/High School Track
- 22% Trade/Vocation Track at Craven Community College
- 17% College Track at Craven Community College
- Five Certificates were earned
  - 1 EMT Basic
  - 1 Welding
  - 1 Phlebotomy
  - 2 Nursing Aide 1

#### NORTH HILLS

- ► 36% High School Track
- > 36% GED Track
- 18% College Track at Wake Tech
- > 10% On Line High School
- Certificates Earned
  - Special Event Planning
  - Career Readiness for Administrative Assistant
  - Entry Level Public Relations Occupations

### 2013-2014 Employment Outcomes

#### CRAVEN

- 100% of youth Volunteered
  - Soup kitchen, Habitat for Humanity, Food Bank of ENC
- 82% of youth were employed and maintained employment through discharge
  - ▶ 10 worked in food service
  - 1 in retail
  - 1 automotive maintenance and service
  - ▶ 1 in Customer Service

#### NORTH HILLS

- 100% of youth Volunteered
  - North Raleigh Ministries, Latino Festival, Deadbroke Farms, Meals on Wheels, Catholic Charities Outreach Center, Interfaith Food Shuttle and Habitat for Humanity
- 70% of youth obtained employment and maintained it
  - Primarily in the food service industry
