CONDITIONS OF LICENSE

It is expressly understood by the applicant organization that:

1. An exempt organization may only conduct bingo games in accordance with the provisions of Chapter 14, Article 37, Part 2 of the General Statutes. All bingo games conducted by an exempt organization are covered by this statute and must be reported in the annual Bingo Audit. No other games of chance resulting in prizes or awards of any kind may be conducted in connection with bingo.

2. A bingo game conducted other than in accordance with the statute or the conduct of other games of chance in connection with bingo is "gambling" within the meaning of Chapter 19 of the General Statutes, and upon conviction of a violation of the bingo statute, an organization shall not operate a bingo game for a period of one year.

3. Exempt organizations cannot contract with private entities to conduct bingo games on their behalf.

4. No bingo license will be renewed until the audit is accepted by the administrator.

5. A copy of the exempt organization's application and license is required to be submitted to the local law enforcement agency by licensee in the county of municipality in which the organization intends to operate before bingo is conducted.
