Jerry Shore of OASIS, Inc. in participated in the recent joint National Network to End Domestic Violence and National Alliance to End Sexual Violence Advocacy Day in Washington D.C. with Kathleen Lockwood, National Coalition Against Domestic Violence policy director, Carianne Fisher, NCADV executive director, and Monika Johnson Hostler, North Carolina Coalition Against Sexual Assault executive director. They attended a federal panel discussion which consisted of key federal department leaders such as Rosie Hidalgo, special assistant to the president and senior advisor for the White House Gender Policy Council, and Shawndell Dawson, director of the Family Violence Prevention and Services Program. Congresswoman Ayanna Pressley spoke about the importance of the missions of NNEDV and NAESV. The event included an evening reception with remarks from congressional leaders including Ted Lieu, Shiela Jackson Lee and Gwen Moore.

North Carolina delegates met with our state's representatives individually to remind them of urgent and ongoing housing, legal, economic, health, safety, and other human service needs. They requested each representative endorse fully funding the Crime Victims Fund to maintain the current Victims of Crime Act funding level, and fully funding Violence Against Women Act to support sexual assault services programs, transitional housing programs and legal assistance programs for victims. They also urged our

representatives to endorse fully funding Family Violence Prevention and Services Act Program because of its

importance for shelter and support services and for prevention activities which historically have been underfunded.
