GCC Hosts First Gang Task Force Meeting

Gov. Josh Stein convened the first meeting of the Gang Prevention and Intervention Task Force, created by Executive Order 21 to reduce gang violence and build safer communities. Co-chaired by Department of Adult Correction Secretary Leslie Cooley Dismukes and Office of Violence Prevention Director Siarra Scott, the task force unites law enforcement, educators, health experts and community leaders to develop strategies that keep young people out of gangs and support rehabilitation. Highlight - REACH of Macon County

With support from the Governor's Crime Commission, REACH of Macon County launched a forensic nursing program to ensure that survivors of sexual assault and domestic violence can access compassionate, trauma-informed care in their community.

For years, survivors in the region faced long travel times to receive medical-forensic exams, an added burden during crisis. Now, thanks to GCC funding and collaboration with healthcare partners, a team of on-call forensic nurses provides medical exams, evidence collection and advocacy services.
