Denise Neunaber

Denise Neunaber is the Executive Director of the North Carolina Coalition to End Homelessness (NCCEH), a position she has held for fifteen years. Under Denise's direction, the Coalition has significantly broadened its scope and impact. It provides staffing and structure for the Balance of State Continuum of Care, a 79-county region that spans the state, and serves as the HMIS Lead Agency for three CoCs and 81 counties. In 2018, immediately following Hurricane Florence, Denise led the creation of Back@Home North Carolina, the state's first disaster rehousing program.

Rebecca joined CEO in November, and in her role as regional director, she provides operational and programmatic support to CEO's offices in Louisiana, North Carolina, and Tennessee. She holds a B. Allan Wachendorder

Allan Wachendorder joined Vera in 2018 as program associate in the Center for Sentencing and Corrections. His work in the Center includes helping to expand access to postsecondary education for people who are incarcerated through technical assistance and policy reform. Prior to joining Vera, Allan worked as the Director of Public Policy for the Michigan Chapter of the National Association of Social Workers for five years where he worked to represent the interests of social workers and the people they work with at the state Capitol. He is also a founding member of Nation Outside, an organization formed and led by formerly incarcerated people with the purpose of engaging in elections and criminal justice reform work. Jennifer M. Lechner is the Executive Director of the North Carolina Equal Access to Justice Commission, a position she has held since 2008. Under her direction, the Commission assesses unmet legal needs, engages in statewide strategic planning, coordinates efforts between the legal aid organizations and other legal and non-legal organizations, manages resource development efforts, and works generally to expand civil access to justice. Before moving to North Carolina, she founded and operated a Maine-based company focused on legal association management. She served as the first Executive Coordinator of the Justice Action Group, Maine's access to justice entity, and as the first coordinator of a unified statewide fundraising campaign for all Maine legal aid providers. Lechner began her career as the legislative counsel to the Maine State Bar Association where she lobbied the state and federal government on behalf of Maine's largest professional trade association.
