- S 207: JJAC recommendations:
  - o Part 1-YDC extended commitment and Post-Release supervision
  - Part 2-Juvenile Transfer Housing changes
  - Part 3-Superior court responsibilities
  - o Part 4-Keeping D-G felony cases in juvenile court
  - Part 5-Raises the minimum age for delinquent and undisciplined youth under juvenile court jurisdiction (child consultation, counselor involvement, parental responsibility)
- H 252: JJAC recommendations
- H 301: Petitions to expunge certain crimes.
- H 173: Separation of Juvenile Justice and Adult Corrections into two divisions
- H 183: Juvenile Court Counselor sensitivity training Agency Bill. Passed prior to crossover but has not moved in Senate
- H 225: Didn't meet crossover
- H 261: Didn't meet crossover

# **Minimum Age Update**

- J. H. Corpening, II, Chief District Court Judge for District 5
  - Presentation by J.H. Corpening, overview of subcommittee's work.

## Public Comment - received following the conclusion of the meeting

"Thank you for your great work on SB207. At Disability Rights NC, we support raising the minimum age to 10 or even higher. It is vitally important to children with disabilities in NC that SB207 be passed as is, without any exceptions or carve-outs limiting its scope and application." -Tara Muller, Disability Rights
"On behalf of the ACLU of North Carolina, I am writing to express our strong support for raising the minimum age to 12 (or at least 10) years old. We need to protect young kids from the trauma of being taken to court and instead focus on helping them thrive. It is essential that this bill be passed without exceptions to its application." – Ann Webb, ACLU of NC
