Legislative Update

Week of March 25, 2019

Members and staff of the General Assembly had their hands full again this week preparing for budget discussions and working to meet approaching deadlines to file legislation. To begin the week, the Senate Select Committee on Prison Safety reviewed the current pay structure for correctional officers and recent salary actions for staff working in prison facilities. Next Monday, the committee will discuss recruitment and retention issues related to correctional officers.

Various divisions of the Department of Public Safety were on the agenda this week in the Joint Appropriations Committee on Justice and Public Safety. On Tuesday, members of the committee heard overviews of the State Highway Patrol and the State Capitol Police; on Wednesday, they received a briefing on the State Bureau of Investigation and Alcohol Law Enforcement agencies; and on Thursday, the committee examined the North Carolina National Guard, the Division of Emergency Management, and the North Carolina Office of Recovery and Resiliency. Secretary Hooks and the respective division leadership attended each of these meetings.

Also of note, a priority piece of legislation for the department was filed this week. Senate Bill 413, *Raise the Age Modifications*, makes technical changes to various statutes in order to facilitate implementation of the Juvenile Reinvestment Act.

- (4) Bills introduced on the report of the House Committees on Appropriations, Finance, or Rules.
