

Sept. 18-20, 2017 Management Planning Meetings

- Team-Intensive review of data, projections, fiscal impact assessments, and the legislation
- Resulted in:
 - 11 subject-specific workgroups that review the associated impact and need in the following five areas:
 - (1) safety, (2) information technology, (3) strategic planning, (4) policy and process, and (5) training.
 - A plan for community stakeholder forums

Stakeholder Forums

- At least one forum in each juvenile district
- Hosted by Chief District Court Judge and Chief Court Counselor
- ▶ To-date: approx. 475 attendees in 10 forums
- Scheduled through May 2018

Community Forums

- ▶ 6 Community Forums

- ▶ Approximately 1,000 folks have signed up for these.

School-Justice Partnerships

Actions to-date

- AOC & Chief Justice tasked judges with collaborating in counties with stakeholders to identify solutions
 - Creating Toolkit
- Judge Jay Corpening consulted
- JJAC also formed subcommittee, led by Corpening
- JJ county-specific data being provided to local decision makers

Greater Protections for Victims

Effective Oct. 1, 2017

Victims

- Must be notified of filing decision, reasons for the decision, and whether matter was closed, diverted, or retained;
- Must be notified of right to have prosecutor review filing decision under amended G.S. 7B-1704 and G.S. 7B-1705; and
- Under new G.S. 143B-806(b)(14a), DJJ must develop system for informing victims about status of pending complaints and right to review the filing decision.

Greater LEO Access to Information

Effective Oct. 1, 2017

- DJJ must begin tracking "consultations with law enforcement" that do not result in the filing of a petition per amended 7B-3001(a)
- Duty to share info. applies to:
 - Juvenile's delinquency record & consultations with LEO's
 - When requested for the purpose of assisting LEO's during the investigation of an incident that could lead to the filing of a complaint
- Certain Limitations Apply:
 - LEO's may not obtain records from JCC's
 - LEO's must maintain confidentiality of any information shared

Issues JJAC will make a recommendation on in the future (by 1/15/19 report):

- Definition: "violation of the motor vehicle laws under State law"
- Timeframes (e.g., probable cause hearing)
- Gang Suppression method of proof and burden of proof [G.S. 7B-2508(g1)]
- Specific costs associated with housing 16 & 17 year old transferees


Staggered Implementation

- ▶ Would cost additional \$647,600 in planning funds
- Delaying implementation of 17 year old population would result in a postponement of \$29,263,274 in annual savings



New complaints will enter slowly over time

8,673 new JJ Youth in 2020: Offense trend NOTE: Complaints filed an average of 32 days following offense.





Staggered Implementation

▶ The requirement to include "Cost estimates for capital, operating, and staffing costs if the implementation of the section is staggered based on age" refers to extending the juvenile age to 16 at one point, and then extending the juvenile age to 17 at another point. This approach is not recommended, as the implementation savings of forgoing full implementation until a later date is not as great as the implementation barriers, process redundancies, or savings realized by implementation


- Programming resources to respond to 3 distinct areas of the legislation:

Expansion Recommendations- Early Intervention

\$3.4 million

- Juvenile Crime Prevention Council (JCPC)
 Funding Expansion
 - Serves as viable resource for School-Justice Partnership efforts through a variety of locally chosen program types
 - Provides flexibility of programming options to fill gaps in services
 - Expands capacity of existing programs impacted by Raise the Age legislation
 - Creates access via regionally administered programs (collaboration via multi-county programming)
 - Special Provision language to prepare Juvenile Crime Prevention Council
 - Multi-year funding cycles
 - Multi-county/district funding

Expansion Recommendations- Residential


- Addresses capacity needs and reduces current waitlist
- Regionalized access to services (Piedmont, Central, and Western area need)
- Transitional Living Home expansion to address older population
- Request that contractual funds be committed to begin RFP process for residential programs
 - Special Provision language
 - Securing sites
 - Contract award processes

Rockingham County YDC

- 60 beds @ 45,000 Sq. Ft., five 12-bed pods
- One pod is flex designed
- Includes classroom areas, gym, kitchen & dining, clinical, admin, vocational, and visitation space
- Allocated to-date: FY 17-18, \$13,200,000 NR
- Additional \$5,193,000 needed for site planning, land acquisition, and site preparation/work
- 114 staff will be needed
- Opens February 15, 2022





Transfers

- Umstead (E-Cottage) at C.A. Dillon
 - \$1,998,000 (20 beds and driveway/road repair)
 - Additional renovations will be needed to expand an additional 48 beds at C.A. Dillon (total: 68 beds).
- Jail North (122 beds)
- Guilford County Detention Beds (48 beds)
