## School-Justice Partnership (SJP) Dashboard

## <u>Glossary</u>

**Complaint.** A complaint is a written allegation that a juvenile is delinquent or undisciplined, which is submitted to a juvenile court counselor for evaluation. (source: NC AOC website)

**Delinquent.** Any juvenile who, while less than 16 years of age but at least 10 years of age, commits a crime or infraction under State law or under an ordinance of local government, including violation of the motor vehicle laws, or who commits indirect contempt by a juvenile as defined in N.C.G.S. 5A-31. Any juvenile who, while less than 18 years of age but at least 16 years of age, commits a crime or an infraction under State law or under an ordinance of local government, excluding all violations of the motor vehicle laws under Chapter 20 of the General Statutes, or who commits indirect contempt by a juvenile as defined in N.C.G.S. 5A-31. Any juvenile as defined in N.C.G.S. 5A-31. Any juvenile who, while less than 10 years of age but at least 8 years of age, commits a Class A, B1, B2, C, D, E, F, or G felony under State law. Any juvenile who, while less than 10 years of age but at least 8 years of age, commits a class A, B1, B2, C, D, E, F, or G felony under State law. **Intake Decision (Evaluation).** An intake evaluation involves the screening and evaluation of a complaint by a juvenile court counselor to determine whether a juvenile petition should be filed. (source: NC AOC website)

**School-based offense.** A School-Based Offense is an offense that occurs on school grounds, school property (buses, etc.), at a school bus stop, or at an off-campus school-sanctioned event (field trips, athletic competitions, etc.) or whose victim is a school (such as a false bomb report). School includes any public or private institution providing elementary (K-8), secondary (9-12), or post-secondary (community college, trade school, college, etc.) education, but excludes home schools, preschools, and day cares. (source 2007 Juvenile Justice Annual Report)

## Tips and Tricks

The SJP dashboard consists mostly of **delinquent school-based offenses (SBO's)** received in the past three (3) full Fiscal Years. Total delinquent complaints received, and the three-year percentage change calculation are located in the first widget. The "<5" is used to indicate complaint counts between 0 and 4 inclusive.

The dashboard includes the following variables. Each widget provides interactivity for the user.

- Complaints Received
- SBO Complaints Received
  - By District/County
- By Charged Type
- By Intake Decision
- By Race / Ethnicity


- By Gender
- By Age at Offense (in groups)
- 1. Select a District of interest by left clicking on the District label.



b. Click on the same District label again to show totals across the dashboard for only the selected District.



- 2. User can select more than one variable to obtain specific counts. For example, select the Decision of interest for an Age Group within a given year.
  - a. Click either on the Decision label (i.e., "Approved," "Closed," or "Diverted") OR the bar in the chart that is corresponding to that value of interest.



- b. Next, select Age Group of interest
  - Click either on the Age Group value (i.e., "Under 10," "10 to 11," "12 to 13," "14 to 15," "16 and Older") OR click on the bar that is corresponding to that value of interest.



The dashboard then converts to display all variables (in the widgets) for the Decision and Age selections.
