Following the Memorial Day observance, legislators arrived at the statehouse Tuesday ready to take action. Many bill sponsors are pushing hard now to get their bills heard, with the bill filing deadline in the rearview mirror and priority policy bills being heard in committee. Altogether, this week there were about 20 committee meetings between the House and Senate with over 30 bills considered. Over the course of the week, the House voted on a dozen bills, whereas the Senate took up votes on eight pieces of legislation.

Outside of committee meetings and voting sessions, some legislators have participated in private meetings to discuss budget revisions. Both House and Senate leadership have indicated that the budget will be negotiated *prior* to a floor vote this session. Typically, negotiations occur after the House and Senate have each released their own budget proposals. At this point, it appears that a revised budget is on track to be released sometime in June.

The Senate has not calendared any committee hearings for the week ahead, but is scheduled to have a voting session on Monday. The House, on the other hand, has six committee meetings scheduled for Tuesday and will likely have a voting session later in the day.
