

Legislative Update

Indications suggest that this session may be winding down soon. A clear sign came mid-week with the introduction of Senate Joint Resolution 688, *Adjourn 2019 Session to Date Certain*, which would adjourn the 2019 Regular Session on Monday, July 22nd and reconvene on Tuesday, August 27th to consider those matters specified in the resolution. The resolution's introduction will generate a great deal of activity on Jones Street in the coming week.

The reconsideration of vetoed House Bill 966, 2019 Appropriations Act, was placed on the House calendar for Monday, but the body took no action to override the Governor's veto. Although House Bill 966 remained on the calendar for the next three days, the House continued to take no action, resulting in a standstill. The item appears on the House calendar for next Monday, but it is unclear whether a vote to override will be taken. With the compromise budget in limbo, state government operations continue at current funding levels.

Meanwhile, the House Committee on Appropriations released a Proposed Committee Substitute (PCS) late Tuesday night for House Bill 111, *Supplemental Appropriations Act*. Approved in committee and passed unanimously by the House on Wednesday, the temporary spending measure would remain in place until a full appropriations act becomes law. The stopgap budget bill provides funding for initiatives that would not otherwise be fully funded, such as Raise the Age implementation, which receives over \$27M in FY 2019-20 under the bill.

Regarding the movement of non-appropriations bills, Senate Bill 413, *Raise the Age Modifications*, passed the House Judiciary Committee on Wednesday with a re-referral to House Rules. In addition, the Senate concurred with the House's changes to Senate Bill 29, *Move Over Law/Increase Penalties/Amber Lights*, and the bill was sent to the Governor for approval. Also this week, Senate Bill 5, *School Safety Omnibus*, was amended in the House Committee on K-12 Education. Although much of the bill's original language has been replaced and is similar to that of House Bill 76, *School Safety Omnibus*, critical pieces of language have been omitted. The DPS legislative affairs team will continue to advocate for the inclusion of these vital components. And finally, on Thursday, Senate Bill 290, *ABC Regulatory Reform Bill*, passed its third reading in the House. The bill, which has been sent to the Senate for concurrence, would make various revisions to state alcoholic beverage control laws.
