The project location is within Congressional District 14 represented by Congresswoman Jacki Speier. **Documentation attached.** The proposed mitigation activity will provide 100-year coastal flood protection and sea level rise adaptability for the Pacific Gas and Electric Company transmission-level substation located in Menlo Park. By protecting this transmission-level substation from potential flooding, the project will prevent the loss of electrical service to communities over a large geographical impact area beyond the borders of Menlo Park, including East Palo Alto, Palo Alto, Redwood City, San Carlos, Belmont, Atherton, and the North Fair Oaks area of unincorporated San Mateo County.
