# Legislative Update

Week of March 8, 2021

The General Assembly was full of vigor this week as bill filing deadlines loomed in the Senate. Members focused on a variety of legislation including in-person learning requirements, autism, guns in churches, and ICE detainees.

On Tuesday and Thursday, the Joint Appropriations Committee on Justice and Public Safety met to continue the overview of DPS. Tuesday's discussions focused solely on matters pertaining to the *NAACP v. Cooper* settlement. Members were permitted to ask DPS and DOJ staff specific questions and gain insight into the overall impact the settlement will have on Prisons. During Thursday's meeting, the four DPS law enforcement divisions were the main focus, and all received high praise and sincere appreciation from members for the work they have done during these unprecedented times. Next week on March 16, JPS Appropriations will concentrate on the Administrative Office of the Courts.

- (4) Bills introduced on the report of the House Committees on Appropriations, Finance, or Rules.
