Legislative Update

Week of April 19, 2021

This week at the NCGA, bills glided through committee at a steady pace. 82 bills were filed in the House this week as the filing deadline looms nearer.

Among other news unfolding this week, legislators filed House Bill 608, *Dignity for Women Who are Incarcerated*. DPS worked closely with bill sponsors and stakeholders to put the DPS policy on pregnant women into statute and narrowly tailor other interests from non-DPS parties. More work on the bill is required, but that will take place when the bill is heard in committee.

On Wednesday, Senate Bill 346, *Emergency Management Act Revisions* which seeks to change the Governor's ability to issue executive orders, passed Senate Judiciary. House Bill 304, *Protect Personal Info/LEOs, Judges, DAs* which removes from online websites the home addresses and phone numbers of judges, prosecutors, and law enforcement received a favorable report from the House State Government Committee.

In the backdrop for the next several weeks, the Senate will continue to intricately weave a budget together and pontificate on whether Adult Corrections should separate from DPS.

House of Representatives:

Drafts	Filed in House By 3 PM
Public Bills and Resolutions (Not Approps or Finance)	Tuesday, May 4
Public Bills (Approps or Finance)	Tuesday, May 11

Bills eligible to be filed in 2021 with no deadlines

- (1) Redistricting bills for House, Senate, Congress, or local entities.
- (2) Ratification of amendments to the Constitution of the United States.
- (3) Resolutions pertaining to the internal affairs of the House or adjournment resolutions.
- (4) Bills introduced on the report of the House Committees on Appropriations, Finance, or Rules.

Senate:

The Senate bill filing deadline has passed.
