Audit Findings

Audit Narrative

Nash Correctional Institution (NCI) is located in Nashville, North Carolina, Nash County and is operated by the North Carolina Department of Public Safety (NCDPS). The facility's first PREA audit was conducted in 2015. The current audit was attained and assigned to the auditor by Correctional Management and Communications Group, LLC, located in Minneola, Florida.

The notification of the 2018 on-site audit at NCI was posted on April 9, 2018, six weeks prior to the date of the onsite audit. The posting of the notices was verified by photographs received electronically from the facility's PREA Compliance Manager. The photographs indicated notices were posted in various locations throughout the facility including the housing, program areas as well as work location and administrative areas. Prior to the auditor's onsite visit to the facility the auditor worked with the facility's PREA Compliance Manager in developing and completing the Pre-Audit Questionnaire (PAQ). This document identified the minimum information and supporting documents the facility should submit to the auditor before the onsite audit begins. The NCI PAQ was received on April 23, 2018, and included policies, procedures and supporting documentation, which was within an adequate timeframe for review. The documents were uploaded to a USB flash drive. The initial review revealed well organized documents. Any additional information needed was discussed with the facility PREA Compliance Manager and was received within a timely manner or ready for review onsite. Prior to the onsite visit, the auditor utilized the auditor Compliance Tool. This tool was used during each phase of the PREA audit as a guide in making audit compliance.

The on-site visit was conducted May 21-22, 2018. Upon arrival at the facility, an in-briefing meeting was held with the Correctional Administrator, the facility's PREA Compliance Manager and the Assistant Superintendent of Custody and Operations to discuss the information contained in the PAQ. Site Review Instructions were reviewed describing the areas of the facility to be toured, operations and practices to be observed, and questions that should be asked of staff and inmates in order to conduct a thorough site review. Additionally, interview protocols to be used by the auditor to interview staff and inmates as part of the audit were discussed. Required documentation, relevant observations, the interview protocols, and the audit compliance tool were used to establish evidence of standard compliance. During the tour, the auditor noticed that the facility was well maintained and the sanitation level throughout was very good. While touring each housing unit, the auditor observed shower stalls in the housing units, segregation, and medical with all having shower curtains for privacy purposes and handicap accessible cells and showers. Staff of the opposite gender were announcing as we entered the housing unit throughout the day. The auditor viewed the camera locations from the Assistant Superintendents office and observed the camera locations and viewing capability to protect inmates against sexual abuse.

At the time of this audit, the facility employed 251 employees and 14 contractual staff. The inmate population was 644 adult males. The NCPSD Director, Contract Administrator and the Agency's PREA Coordinator had been interviewed previously. The administrative staff interviewed included the Correctional Administrator and both Assistant Superintendents. A total of 42 staff were interviewed; 12 correctional officers (from both 12.25-hour shifts); three administrative staff; a volunteer, two contract staff and 13 specialized and 11 random staff. Thirty-nine inmates were interviewed which included two with Limited English Proficient, four with Cognitive Disabilities, three inmates who identified as transgender, gay or bisexual; one inmate who

reported an allegation of sexual abuse, eight inmates on work assignment or educational programs assignments and 21 random inmates from the general population. No inmates refused. During this process the auditor did not limit the interview questions to only those included in the protocols; rather, additional site-specific questions were asked as a starting point for eliciting information about the facility's compliance with the PREA Standards.

Responses to the interview questions were part of the auditor's compliance assessment. Inmate interviews support staff's compliance with the facility's prohibition of cross-gender viewing and pat searches. This auditor was provided evidence to ensure compliance to the PREA, as documented in this report.

Facility Characteristics

NCI is a medium-level secure facility for male inmates run under the North Carolina Department of Public Safety (NCDPS). The NCDPS Mission is to promote the elimination of undue familiarity and sexual abuse amongst the offender population. This facility is located in Nashville, NC, in Nash County. The first prison at this site opened in 1938, a close custody facility known as Nash Prison Unit. In the early 1960s, Nash went through a series of changes, including conversion to a misdemeanor facility, a medium custody prison, and finally to a minimum custody unit. In 1970, it was renamed Nash Advancement Center and then renamed Nash Correctional Center in 1988. Nash Correctional Center became part of the newly built Nash Correctional Institution in 1992. The old Nash Correctional Center facility is used for training and storage. The facility has an inmate capacity of 654 inmates who are the age of 21 – 100 years of age. The facility does not house youthful offenders. Opened in 1938 this facility underwent physical changes in 1992 to allow for an increase in inmate population.

The Nash campus consists of 15 buildings, including a medical facility, a vocational building, a recreational building, a gatehouse, a dining hall, a chapel, a 20-cell Restrictive Housing Unit (RHU), and four pods with two wings totaling eight housing units (with 128-cells each). During the tour of the facility the auditor observed that each unit offered single man cells with toilets. In addition, beds were available in the dayrooms of each unit. Each unit dayroom also contains telephones and a grievance box.

Internal vocational jobs available for inmates include Electronics, HVAC, Graphic design and Commercial Cleaning. External jobs available are through Enterprise Industries. The Optical Plant employs approximately 50 inmates. Inmates make prescription eyewear for NCDPS inmates and Medicaid patients. Staff are also able to have their eyewear made at this facility. Due to laws, there is no apprenticeship offered through this program. The Print Plant offers employment for 120 inmates daily on two shifts. This is a printing site for the state agency. Both of these plants offer inmate supervision through Enterprise Industries staff and prison security staff. The facility also houses a Cooperative Generator Plant. One of only two in the state, the plant puts power back into the grid. Inmates are not provided work opportunities here with the exception of cleaning floors. Additional programming includes educational and vocational opportunities. Educational services offered include Adult Basic Education and General Education Diploma testing. Other services offered include Crossroads, Living on the Outside, Career Readiness, and Life Skill Preparation. Unique to this program is the "New Leash on Life" program. A Canine training program where three dogs at a time are brought into the facility for a 6-month training by inmates to assist with social skills and basic dog commands.

There are 4 cameras in each of the housing units to allow for additional supervision. Additionally, in each building there are a variety of offices or spaces to provide additional services for both inmates and staff. These may include a break room for staff, staff bathrooms, classrooms, case manager offices, Sergeants

Office, canteen, library, barber shop, and medical care. There are 118 cameras throughout the facility. The Operations Center has viewing capability. The shower areas facing the control unit are painted that allows for inmate privacy in the shower and while using the toilets. The facility is able to maintain recordings for 30 days. Additional spaces or areas at the facility include the chapel, gymnasium, warehouse, dining hall and kitchen.

Medical staff are available at the program 24/7. The physician is available 3 days per week. There are two psychologists assigned to the facility fulltime at the time of the audit. A third position is in the process of being filled. Those employees are typically at the facility Monday-Friday, from 8-5. An on call provider from a duty roster is called at night, weekends and holidays. The facility does have a Sexual Assault Response Team (SART) to respond as needed. PREA Support Person program is in place and there are six trained staff. These persons respond as necessary and have received specific training to assist victims through all processes, including providing assistance in obtaining outside support services. The Superintendent has identified both a PREA Compliance Manager (PCM) and a secondary person as well.

The NCI follows the agency's policy mandating zero tolerance toward all forms of sexual abuse and sexual harassment. North Carolina Department of Public Safety (NCDPS) PREA Inmate Sexual Abuse and Harassment Policy F3400 meets the mandates of this standard. The Agency's zero tolerance against sexual abuse is clearly established and the policy also outlines the agency's approach to preventing, detecting and

responding to sexual abuse and sexual harassment allegations. The policies, along with additional policies and standard operating procedures, outline the prevention, detecting, reporting, and response to sexual abuse and sexual harassment allegations. Definitions that mirror the PREA Standards are included in the policy, as well as sanctions for those who violate policy. All interviewed shared their knowledge of the strategies and responses towards PREA allegations.

In addition to the facility PREA Compliance Manager, there is a designated agency-wide PREA Coordinator to ensure adherence to the PREA. The PREA Compliance Manager/Correctional Captain reported sufficient time to meet the needs of PREA compliance with assistance, as she had only been in the role a very short time. Additionally, a secondary PREA Compliance Manager has also been identified, again within the last 30 days. This position reports directly to the Superintendent, and indirectly to the Agency PREA Coordinator. The agency also has a PREA Coordinator, Charlotte Jordan-Williams, who reports to general counsel, and who has reported sufficient time to attend to PREA duties.

Zero Tolerance posters are displayed throughout every area of the institution. Both institution staff and inmates are provided with a variety of opportunities to become aware of the PREA. Staff receives initial inservice training and annual cycle training, thereafter. Both the Agency PREA Coordinator and facility PREA Compliance Manager advised they have sufficient time and authority to coordinate efforts to comply with PREA standards. The Agency and facility have a zero tolerance for all forms of sexual abuse and sexual harassment.

State of North Carolina Department of Public Safety Prisons Policy F1600 Staffing Plan Report dated January 2015, approved Facility Posting Chart/Staffing Plan approved 06/08/15, North Carolina State Statute 143B-709 and Daily Activity Logs meet the mandates of this standard. Interviews with the Correctional Administrator and Human Resource Manager revealed compliance with PREA and the elements listed in the standard. The Administrator stated that safety and security issues are always a primary focus when they consider and review their respective staffing plan. Cameras are strategically located throughout the facility to include the main gate, front lobby and visiting rooms. Additional video monitoring systems are considered at staffing meetings and a proposal has been submitted for various monitoring devices to be purchased and installed to increase safety and security for staff and inmates. Sufficient staff are currently assigned to each shift to ensure the safety of both offenders and staff. The facility reviews the staffing plan at least annually and the staff complement is adequate. There have been no instances where the staffing plan was not complied with. While state statute requires a staffing analysis every 3 years, the NCDPS Prisons policy requires an annual review of the staffing plan, including a review of all required components of the standard, which was completed in January 2017. The Prison Post Chart shows all positions for each shift. All staff deviations are noted in the daily shift narrative, to include staff calling in sick, staff being pulled from post for emergency medical trips, staff on vacation or staff in training.

Unannounced rounds are clearly documented in the Daily Activity Log and are conducted by both the Superintendent and the Assistant Superintendent. Documentation of unannounced rounds covering all shifts by administrative staff was reviewed. Interviews with higher level facility staff confirmed unannounced rounds to all areas of the institution are conducted on a weekly basis, with no warning to staff. Additionally, all supervisory and management staff are required to conduct rounds of all areas in order to provide supervision, including the Enterprise operations.

The NCI has trained all staff on cross-gender viewing and searches. Facility procedures prevent female staff from conducting strip searches, unless in exigent circumstances. The program makes a general announcement at the beginning of the shift that female staff may enter the unit. Female staff entering the housing areas are required by policy/memo to announce their presence, and this was observed during the tour. However, interviews indicated that these are only conducted at the beginning of the shift and typically are never announced again. Policy requires documentation of any cross-gender searches. There were no reported cross-gender searches conducted. Training documents reviewed indicated that staff have completed appropriate training and staff were able to articulate the training when interviewed.

Staff interviewed indicated they received cross-gender pat search training during initial and annual training. During the tour of each housing unit, the auditor observed shower stalls in the housing units, segregation, and medical having shower curtains or barriers for privacy purposes. To strengthen the overall privacy in the segregation units, the Administrator has proposed to install additional curtains directly to the shower doors which obscure the outside view of the shower up to a height consistent with the curtains used throughout the rest of the facility. Inmates, officers and administrative staff stated inmates are allowed to shower, dress, and use the toilet privately without being viewed by the opposite gender. Inmates and staff reported that staff of the opposite gender announces their presence before entering a housing unit and at the beginning of the shift. Additionally, the auditor observed written notifications that opposite gender staff routinely come into the units are posted at the entrance of living areas and throughout the units. The postings are written in both English and Spanish. Staff was well aware of the policy prohibiting the search of a transgender or intersex inmate for the sole purpose of determining the inmate's genital status.

The agency has established policy to provide for educational services for inmates with disabilities to be provided information at intake and assistance on PREA allegations, including reporting. Case managers would arrange for education in formats for those inmates identified as disabled. NCDPS Prisons policy also addresses the provision of interpreters to those inmates with a non-English primary language. There is a contract in effect with World-Wide Interpreters Telephonic Interpreter Services Company. In March 2016, the NCDPS signed a contract with Linguistica International, Inc. regarding telephonic interpretation services. Policy prohibits the use of inmate interpreters except in exigent circumstances. PREA documents in English, and some Spanish, were observed.

Staff interviewed was aware of the policies that, under no circumstances, are inmate interpreters or assistants to be used when dealing with PREA issues. In addition, an interview with the PREA Compliance Manager revealed that they consult with the facility's maintenance administrative staff as necessary, to ensure that American Disability Act (ADA) accommodations are feasible. Inmates that require additional

ADA accommodations may submit a request to their unit manager for assistance. The facility's maintenance supervisor reviews each case separately and ensures that inmates at NCI are provided with information regarding ADA disability accommodations.

During the tour the auditor was able to see and inspect ADA accommodations in housing and common areas of the facility. Offenders have access to auxiliary aids such as visual aids, written materials, assistive listening systems if needed and teletypewriter equipment to assist with conversions of spoken conversationto-text or text-to-audible conversations. Inmates requiring the use of wheel chairs are housed in cells that are wheelchair accessible. If required, inmates may be scheduled for an individualized assessment with licensed specialist for recommendations of auxiliary aids and services that may assist in providing effective communications. The agency has established policy to provide for educational services for inmates with disabilities to be provided information at intake and assistance on PREA allegations, including reporting. Case managers would arrange for education in formats for those inmates identified as disabled.

Forms HR005, HR0008, HR013 used to document the agency's hiring practices were reviewed in addition to a Memo regarding PREA Hiring and Promotions (dated October 2013) with addendum to the Memorandum, a list of Disgualifying Factors; Employee PREA Employee Statements and samples of employee background screening results Staff Interviews. The NCDPS Prisons policy prohibits the hiring or promotion of individuals who have engaged in sexual abuse, or attempting to engage in sexual abuse in a detention facility or in the community, or who have been civilly or administratively adjudicated for the same. Five-year background screenings have not been completed on all staff. The agency requires all staff to annually sign a statement that they have not engaged in the aforementioned activities (PREA Hiring & Promotion Prohibitions and HR005). This information was reviewed through the Learning Management System (LMS) and copies were provided to the auditor. A review of the LMS documentation indicated that all staff have completed this form. The agency also requires all employees to self-report any such misconduct. Criminal background checks are required for contractors, and material omissions regarding misconduct or false information are grounds for termination. The agency does respond to requests from other institutions where a former employee has applied to work. On March 17, 2016, the agency updated their systems to include a 5-year background screening for all staff. There have been no recent upgrades to the facility. NCPSD has a plan that assists the agency's continued efforts to prevent rule violations and misconduct to include the prevention of sexual abuse throughout the entire facility. In developing this plan standards from the Prison Rape Elimination Act, specifically Standards 15.13, Supervision and Monitoring, and 115.18, Upgrades to Facilities and Technologies, were taken into consideration. Presently NCPSD has adequate cameras installed in living units and strategically placed in areas to include the visiting and security gate area. Monitors are available in the Main Control Units and can be viewed in the Administrator and the Assistants computer consoles. The auditor viewed the camera locations from the Administrator's office and observed the camera locations and viewing capability to protect inmates against sexual abuse. During the interview with the Administrator he indicated how the installation of additional cameras and video monitoring system and electronic surveillance system, would enhance the agency's ability to protect inmates from sexual abuse safety of both offenders and staff on each shift.

The agency conducts only administrative investigations. Nash County Sheriff's Office completes all criminal investigations. Uniform Evidence Protocols are in policy and are appropriate. The facility has identified PREA Support Persons (PSP) who are trained for victim advocacy services, and act as the link to assist victims with the investigative process, professional resources, community based advocates, and mental health professionals. The agency is currently working with the North Carolina Coalition Against Sexual Assault (NCCASA) to create a state-wide system for community-based services. Documents were provided for auditor review. The facility has maintained its association with "My Sister's House," a local rape crisis agency to provide services for inmates. Information is posted in the housing units. The facility PREA Support Persons also assist the inmate in contacting this crisis center when requested.

Forensic examinations are conducted through the Nash Healthcare System, and a letter was provided signed by the Sr. Vice-President/CNO. The facility PREA Compliance Manager informed the auditor that the Nash County Sheriff's Office will provide their assistance in PREA compliance regarding evidence protocols. On March 17, 2016, the agency sent out a letter to all law enforcement in the state that assist their facilities requesting their compliance with investigations which will meet PREA requirements. Correctional and Health Services staff was interviewed concerning this standard and all were knowledgeable of the procedures required to secure and obtain usable physical evidence, when sexual abuse is alleged. Staff is aware the Internal Affairs Investigator conducted investigations relative to sexual abuse allegations. The current established facility protocol mandates that all forensic medical examinations be conducted by a Sexual Abuse Nurse Examiner/Sexual Abuse Forensic Examiner (SANE/SAFE) nurse. Nash HealthCare Medical facility has SAFE/SANE forensic/nurse examiners on staff. The examinations are performed without cost to the offender. Qualified Mental Health Professionals are also on staff at the facility to provide victim advocacy services.

A review of the facility's investigative files indicate that the agency have a policy and practice in place to ensure that allegations of sexual abuse or sexual harassment are referred for investigation to an agency with the legal authority to conduct criminal investigations, unless the allegation does not involve potentially criminal behavior. The PREA Compliance Manager stated that when received, all incidents receive an investigation, both administrative and criminal (if criminal in nature). Allegations are referred to an in-house trained investigator (3 at this facility) for the administrative portion and to the Nash County Sheriff's

Office for criminal investigations. When there is substantial evidence a criminal act has taken place, the case is referred to the State's Attorney for possible prosecution. There have been no referrals in the past 12 months. Policies are available through the NCDPS website. Of the allegations of sexual abuse and sexual harassment at this facility, a review shows that none met the need for criminal investigation.

The agency policies require annual training for all staff in all areas identified within the standard. Interviews with staff confirmed they complete annual training and understand the material presented. Staff interviewed indicated they were required to acknowledge, in writing, not only that they received PREA training, but that they understood it as well. Training documentation is kept in Learning Management System (LMS). Employee training documentation found that all staff files reviewed show completion of the annual training (PREA: Sexual Abuse and Sexual Harassment 101). Staff was able to articulate the training they had received during the interviews. It was also reported that a variety of PREA-related material is provided to staff during the year, in addition to their annual training. Newly hired employees receive extensive training relative to PREA standards at their initial training at the Training Academy. In addition to reviewing the training curriculum, training sign-in sheets and policies, other related documentation was reviewed from the

Pre-Audit Questionnaire. Other related documentation reviewed included Policy F3400; the training Curriculum's SAH 101, Staff and Offender Relations Training; New Employee Orientation Form OPA-T10; Employee Training Files and training handbooks, to verify compliance with this standard.

The agency requires all volunteers to complete the same training as staff, with minor deviations. There is also a Volunteer Brochure specifically for volunteers to receive PREA information. This facility reports over 75 volunteers that provide services to inmates. There are 14 contractors and 56 volunteers who have received PREA training over the past 12 months. The training included the agency's zero tolerance policy and reporting and responding requirements. The training is documented, and copies of training sign-in sheets and other related documents were reviewed by this auditor. There is also a "Ways to Report" poster

to remind volunteers and contractors of the various ways to report which was found posted in the facility. An interview with one of the volunteers confirmed that the training was completed and the volunteer understood how to report. The volunteer reported having been visiting the prison for over seven years and has received all training.

The NCI and NCDPS Prisons policy requires all inmates entering into the system to receive intake and comprehensive training at the reception and diagnostic center. NCDPS Prisons policy F.3400, Diagnostic Procedural Manual Section 201 & 417, PREA Inmate Brochures (English/Spanish), Offender PREA Education Acknowledgement Form T100, the Facilitator Talking Points (Education upon Transfer) as well as PREA Education Upon Transfer to NCI, the Offender Population Unified System (PREA OPUS) was just a few of the documents reviewed during the Pre-Audit as well as on-site reviews, to verify compliance with this standard.

The initial and orientation PREA education process is initiated at the Craven Correctional Center – one of the reception and diagnostic centers. A review of the materials provided indicated that it meets the requirements of the standards. Upon transfer, all NCI inmates receive information that is specific to the facility. Inmates, at intake, receive an agency PREA Brochure and the Inmate Handbook. Both of these contain information regarding the Zero Tolerance Policy and how to report sexual abuse/harassment. All inmates are required to sign that they have received these items. While the agency has "Talking Points" for the orientation facilitator, it was recommended that the document be revised to provide a more

comprehensive orientation process. NCI maintains inmate education in Offender Population Unified System (OPUS) and the auditor reviewed the information.

Interviews with inmates confirmed that they have received both the brochure and the handbook. Informational posters regarding sexual abuse reporting were observed around the facility for inmate and staff viewing. Interviews with two limited English inmates indicated that they were provided written material in Spanish during intake. A new PREA brochure with appropriate contact information for reporting abuse/harassment has also been provided and posted. According to inmates interviewed, information was available on the "My Sister's House" during orientation with case workers. The PREA "Ways to Report" bulletin posted in each unit provides the contact information for My Sister's House for inmate review.

The facility has three designated investigators who have completed specialized training for this purpose, as well as the standard PREA 101 for all staff annually. The training meets the requirements of the standard. Interviews with all three investigators indicated that they were well versed in administrative investigations. Only staff that have completed this training have access to the electronic incident report system to allow for the review of investigations and updating the system with new information. The agency only completes administrative investigations. All criminal investigations are conducted by Nash County Sheriff's Office. This auditor reviewed the specialized training outline and documentation on file and it included techniques for interviewing sexual abuse victims, sexual abuse evidence collection in confinement settings and the proper use of Miranda and Garrity warnings. When required, the facility investigators refer sexual abuse investigations to the Nash County Sheriff, who follow the requirements of the standard. In addition, Policy F3400 Training Curriculums: Investigator, Investigator Understanding Sexual Violence & PPT; and Incident Reporting, Offender Population Unified System (OPUS), Incident Reporting Pamphlet were additional documentation reviewed to verify standard compliance and Investigators knowledge levels.

All agency risk assessments are conducted at the reception and diagnostic center upon the initial intake of inmates into the state system. Inmates are assessed during an intake screening for their risk of being sexually abused by other inmates or sexually abusive toward other inmates. This is completed within 72 hours of arrival. Policy F.3400, Diagnostic Procedural Manual 305, Manual on Risk to Sexual Victimization & Abusiveness Screening Guide, as well as inmate files and staff Interviews, were reviewed to verify compliance. The risk assessment conducted includes all elements of the standard. Information is obtained regarding vulnerability using an objective tool for the identification of inmates who are vulnerable to victimization. This assessment is required to be reviewed within 30 days of intake. Within a set time period not more than 30 days from the inmate's arrival at the facility, the facility unit team staff reassess the inmate's risk of victimization or abusiveness based upon any additional, relevant information received by the facility since the intake screening. If the inmate reports victimization or identifies as sexually aggressive, notification is made to medical, the Administrator and the PREA Compliance Manager to begin services as

required by policy. The policy prohibits inmates from being disciplined for refusing to answer questions from the screening. Only those staff with appropriate credentials has access to this electronically maintained information.

The agency PREA Coordinator provided to this auditor documentation that the agency now produces a High Risk for Victimization List (HRV) that is reviewed alongside the High Risk for Abusive List (HRA) to ensure that all housing, work, and programming services are assigned with the protection of the inmates as a key factor. Upon intake at a reception center, the inmate and staff complete the Mental Health Screening Inventory. This tool identifies all required components of the standard. From this document, two lists are produced – the HRV and HRA (see above). These lists are protected from viewing by staff who do not have an immediate need to know and access is only provided to the facility Head, PREA Compliance Manager, Assistant Superintendent for Custody and Operations, Assistant Superintendent for Programs, and the Inmate Assignment Coordinators (IAC). It is the responsibility for the designated staff to run these lists weekly to review for appropriate placement. NCI has completed as of March 18, 2017, a review of all inmates on the HRV and HRA list, as well as changes made to ensure the safety of inmates.

The policies F.3400 & TX-I-13, Screening tool Learning Management System (LMS) addresses clear guidelines, including limits, for housing and work assignments based on the safety of all inmates. The policy requires a bi-annual review of housing for transgender and intersex inmates. The policy also provides for all transgender and intersex inmates to shower separately from all other inmates, and is assessed for their own perception of risk at the facility. NCI has identified those inmates deemed at high risk for sexual aggression, and has implemented methods of reviewing all housing, programs, and work assignments to ensure the safety of all other inmates, to include those inmates who are identified as vulnerable to victimization. The agency currently has a system to include a review of the High Risk Victimization (HRV) and the High Risk of Aggressive (HRA) list at the facility on a weekly basis, or more often if needed, to ensure that inmates are placed in educational, vocational, and housing that ensures their safety. Inmates who are identified as HRV are now placed in closer proximity to the staff in the housing units. This information was provided to the auditor to show that NCI completed the first run of this new system and made changes in order to protect inmates.



Policy states that services for an inmate who may be placed in protective custody are continued as normal unless there is a specific documented reason for restriction. Offenders at high risk for sexual victimization are not placed in involuntary segregated housing, unless an assessment of all available alternatives has been made and there is no available means of separating the inmate from the abuser. Access to programs, privileges, education and work opportunities are not limited to inmates placed in a restricted housing unit for the purposes of protective custody. Should any restrictions apply, the facility would document the privileges that were limited, the rationale for the limitation and the duration of the limitations. The inmates are reassessed at least once every 30 days, after being placed in the segregation unit.

There were no inmates at risk of sexual victimization held in involuntary segregated housing in the past 12 months for one to 24 hours awaiting completion of assessment. Additionally, there were no inmates at risk of sexual victimization who were assigned to involuntary restricted housing in the past 12 months for longer than 30 days while awaiting alternative placement. There were no inmates in protective custody status during the time of this audit. NCI Restricted Housing was visited and all documentation indicates that the area is also used at this facility when needed to protect inmates who make PREA allegations by placing the accused inmate in separation status during the investigation and there is no available means of separating the inmate from the abuser.

The NCI has numerous ways for an inmate to internally report sexual abuse or sexual harassment. Methods of reporting include telling a staff, writing a grievance or letter to the PREA Coordinator and third-party reporting. The agency uses Forgiving Ministry for external reporting. "In mid-2017, NCDPS connected with Forgiven Ministry, a 501 (c) non-profit organization. Information was sent to each facility in November 2017 detailing upcoming events that are needed to be put into place, including training, orientation material changes, and the phone lines. An MOU was signed in January 2018 that identifies Forgiven Ministry as the

statewide external agency for inmate reporting. This MOU is in effect for one (1) year, and can be renegotiated annually thereafter. Forgiven Ministry, Inc., located in Taylorsville, NC, has agreed to accept calls from inmates alleging sexual abuse or sexual harassment. Inmates will now be educated on how to access Forgiven Ministry through the facility phone system at intake, as well as facility wide education for current inmates. Inmates will not be required to identify themselves when making these calls, nor enter their inmate PIN or other identifying information. GTL, the phone company, is offering a free line that will covert calls to digital mail. This call will be sent by e-mail to both Forgiven Ministry and the NCDPS. Once per month, the Agency PREA Coordinator will meet with the Director of Forgiven Ministry to review calls received in order to ensure an investigation was started. As of January 10, 2017 the phone system had yet to be activated in facility. This was discussed at the exit meeting. A conversation with the Director of Forgiven Ministry confirmed that she signed an MOU with the NCDPS and had been receiving e-mails with a digital recording of reports. She reported five (5) having been received up to this time and that none of the five (5) contained any information that alleged sexual abuse or sexual harassment. She stated that two (2) were "test calls" from unknown facilities and the remaining three (3) were hang-ups. She reported that she is starting a log book and will make contact with the NCDPS PREA Coordinator on a regular basis to ensure that all calls have been forwarded for investigation by NCDPS."

The posters in the facility provided the address for PLS. Interviews with inmates confirmed that many are aware of all reporting methods or contact information for reporting. Interviews confirmed that staff is aware that they may report privately through the Fraud/Waste/Abuse Hotline or through email with the PREA Coordinator if they do not wish to report through the Chain of Command.

During the facility tour observation of all bulletin boards located in the housing and common areas have been updated with the Agency PREA "Ways to Report" which detail telling a staff, writing to the PREA office, Third party reports/Family reports, and PLS. The PLS service forms that are available to the inmates, also contains the specific information required to make a report. Additionally, the facility has incorporated the new PREA brochure into their orientation. This brochure has been updated with current information on how to report, along with contact information.

The NCDPS Prison Policies F0300 & G0300 and the Inmate Rule Book, confirms that grievances of sexual abuse or sexual harassment require an immediate notification to the North Carolina Department of Public Safety PREA office. Inmate Grievance Forms were observed (English and Spanish) and meet the mandates of this standard. Offenders are permitted to file a grievance alleging sexual abuse at any time, without using the informal grievance process or submitting it to the staff member who is subject of the complaint. There is no requirement to use a less formal method of reporting prior to a written grievance. There is no disciplinary action if the report is made in good faith. A final response is due within 90 days, as well as notification to the inmate that it has been accepted within 5 days. Grievances are allowed to be prepared by the victim or other third party person who assists the victim. Emergency grievances, those defined as matters that present a substantial risk of physical injury or irreparable harm may be presented directly to the Officer in Charge, are forwarded immediately to the appropriate person. There were no grievances in the past 12 months that alleged sexual abuse or sexual harassment. The facility has developed a partnership with the North Carolina Coalition Against Sexual Assault (NCCASA) to create a state-wide system for community-based services and for the provision of this standard to provide victim advocacy services. Documentation was provided for auditor review. The facility has maintained its association with "My Sister's House," a local rape crisis agency to provide services for inmates. Information is posted in the housing units. The facility PREA Support Persons also assist the inmate in contacting this crisis center when requested. No inmates housed in this facility are detained solely for civil immigration purposes.

The facility enables reasonable communication between inmates and these organizations and agencies in as confidential a manner as possible. Inmates are informed as part of their orientation process that all telephone calls are subject to monitoring and recording. Monitoring notices are also posted next to each telephone designated for inmate use. The Inmate Rule Book outlines the steps of how to report and who to report to, and where to report, along with the PREA Report Line telephone number. Information about services offered was observed posted in each unit for inmates with contact information available. Inmate interviews indicated that they are aware of contact information. All staff indicated they would act immediately to protect the inmate. They also stated they would separate the potential victim/predator, secure the scene to protect possible evidence, not allow inmates to destroy possible evidence and contact the shift supervisor, medical and psychology staff. The NCI policy requires all staff to separate, protect physical evidence and the crime scene, and to report to administration when an allegation of sexual abuse is received. Policy dictates a member of the security staff shall be promptly notified, if the first responder is other than security staff. Interview results further indicated staff know to separate the inmates, secure the scene, would not allow inmates to destroy any evidence, contact the shift supervisor and refer the inmate to medical and psychology staff. Over the past 12 months there were 3 reported allegations that an inmate was sexually abused. The number of non-security staff as a first responder was zero. Staff interview responses revealed that they could clearly articulate these steps. A review of the staff PREA training 101 training curriculum and Policy F3400, identified security and non-security staff duties as first responders. Contractors and volunteers are required to protect the victim and report the information to a security staff.

The NCDPS Prisons policy addresses practices to protect both staff and inmates from retaliation as a result of reporting sexual abuse or sexual harassment information. Various protection methods for inmates are identified in policy. The Agency has a comprehensive monitoring program in place that includes periodic

status checks for inmates or the provision of monitoring beyond 90 days, if there is a continuing need. The review shall include, but not be limited to disciplinary reports, housing, program changes and facility transfers for the offender and negative performance reviews and job assignments for staff. NCI PREA Retaliation Monitoring staff uses Forms OPA-I22 & Form OPA I24 to document periodic status checks, protection measures employed, concerns reported by the offender. Additionally, the form is used to document the concerns reported by the staff member, protective measures employed and whether the monitoring will be continued past the initial 90 days. A review of facility documents confirmed that retaliation monitoring is conducted. Interviews with staff confirm that retaliation monitoring begins when the allegation is made and following through for a minimum of 90 days. Both the PREA Compliance Manager and the PREA Support Persons are responsible for retaliation monitoring. Investigation files were reviewed and the sample reviewed showed retaliation monitoring in compliance with the standard.

The NCDPS Prisons policy requires that criminal investigations are conducted by Nash County Sheriff's Office, therefore the facility investigators only conduct an initial investigation to determine if outside law enforcement is to be notified and administrative investigations. The agency does not use polygraph examinations in order to continue an investigation. Administrative investigations address staff actions, credibility and a review of fact and findings of the criminal investigation (if applicable). All interviews are conducted as approved by the Office of Special Investigations and Compliance. There were no allegations that were referred for criminal investigation.

A review of documentation and staff interviews concluded all facility investigators have received the necessary special training in sexual abuse investigations. The Investigators informed this auditor of their duties and actions to include gathering and preserving direct and circumstantial evidence, including any available physical and DNA evidence, and any available electronic monitoring data. The investigators conduct interviews with the alleged victim, suspected perpetrator and potential witnesses. The trained investigators also review prior complaints and reports of sexual abuse involving the suspected perpetrator. When the quality of evidence appears to support criminal prosecution, the agency conducts compelled interviews may be an obstacle for subsequent criminal prosecution. Agency Policies F.3400 & CP-18, Diagnostic Manual 305, Memos dated 10/09/13 and 11/14/12 North Carolina Authorization for Release of Information, Mental Health Screening Referral system, and Learning Management System (LMS) were reviewed and supported the agency's compliance with this standard. The initial intake/orientation and screening process is initiated at the Craven Correctional Center or one of the reception and diagnostic centers. The NCDPS Prisons policy requires immediate referral to medical and mental health services after information of prior sexual victimization or sexual aggressive behaviors is discovered during the screening process. A review of the inmate files provided indicated that medical and mental health screenings for history of sexual abuse is being documented in the mental Health Screening System and meets the requirements of the standards. Upon transfer to NCI inmates receive follow-up as needed that is specific to their medical or mental health needs. The agency requires that all inmates who report sexual abuse shall be immediately taken for medical services. Medical staff contacts the Triage Unit or direct the inmate to the local ER. Mental Health professionals are notified through the PREA Support Persons (PSP). Interview with Mental Health staff confirmed that notifications will be forwarded. Additional counseling services are available as identified and as requested by the victim through the PSP. Provisions for STD testing and treatment are provided at the facility level based on physician orders and/or victim request. All treatment related to sexual abuse is offered without financial cost to the victim regardless if they name the perpetrator or not. There were no allegations that were reported immediately after alleged or within 72 hours of the event.

Again, all services are provided to the victim without financial compensation. The agency also offers evaluations to sexual aggressive inmates when information is present or a new allegation is made. The medical professional reported that all treatment is provided per physician order and that there are protocols in place to further refer an inmate for other treatments.
