# North Carolina Prison Reform Advisory Board

## Objectives

Enhance safety and security for close custody male facilities.

Increase flexibility for managing female offender population.

Improve recruitment and retention for Lanesboro Correctional Institution.

Create a male Protective Custody Unit (PCON) for Close Custody offenders.

Rebrand Lanesboro Correctional (LCI).



### The Plan

Convert Lanesboro Correctional Institution (LCI) to a medium/close custody female facility. \*LCI minimum unit continues to house minimum custody males.

Convert Southern CI (SCI) to a close custody male facility. \*SCI Minimum Unit continues to house minimum custody males.

Convert Eastern CI (ECI) to a close custody male facility, creating a protective custody housing unit.



### The Plan

Re-open North Piedmont Correctional Center for Women (NPCCW) to house minimum custody females. \*Employees from SCI will be deployed temporarily to NPCCW.

Temporarily convert Neuse Cl (NCI) to house female offenders.

Notified the facilities Informed stakeholders Began reducing male population at Neuse Conduct training for staff at Neuse

#### <u>May 2018</u>

Held staff meetings at facilities Revised staffing patterns

### May

Began transferring offenders from Southern and Eastern

Began up fit at Southern and Eastern

#### <u>June 2018</u>

Continue population reduction at Southern and Eastern

Re-Open North Piedmont CCW

Begin staff training at Southern and Eastern.

Continue up fit at Southern and Eastern.



## **Moving Forward**

### July 2018

Complete transferring Southern and Eastern Offenders to Neuse and NPCCW Continue up fit at Southern and Eastern Conduct staff training at Southern and Eastern

#### August 2018

Complete Southern and Eastern up fits Begin transferring close custody inmates to Southern and Eastern

Begin Lanesboro up fit

Begin cross-gender training for Lanesboro staff



## **Moving Forward**

### **September/ October**

Complete population reduction at Lanesboro Continue staff training at Lanesboro

#### **November / December**

Complete Lanesboro Up fit Complete staff training Change name from Lanesboro to Anson CI. Begin transferring female offenders to Anson



## **Moving Forward**

### January/ February 2019

Complete transfers to Anson Cl Begin Neuse up fit

### March / April 2019

Complete Neuse up fit Complete transferring male offenders to Neuse
