A-2 Fuel Needs

- Fuel may be obtained at the Troop A, District 2 Office.
- Fuel may be obtained at the DOT Shop on Powell Stokes Road, Windsor, NC.
- In the event the power is lost at the District Office, fuel may be obtained at the Department of Transportation Facility on Modlin Road in Union.
- In an emergency situation where fuel cannot be obtained at either of the above mentioned locations, fuel may be obtain commercially, if available, by using the Voyager Fleet Card, which will be in the possession of a District Supervisor.




Post 1 – US17 & NC45 – Midway (2 Troopers)
