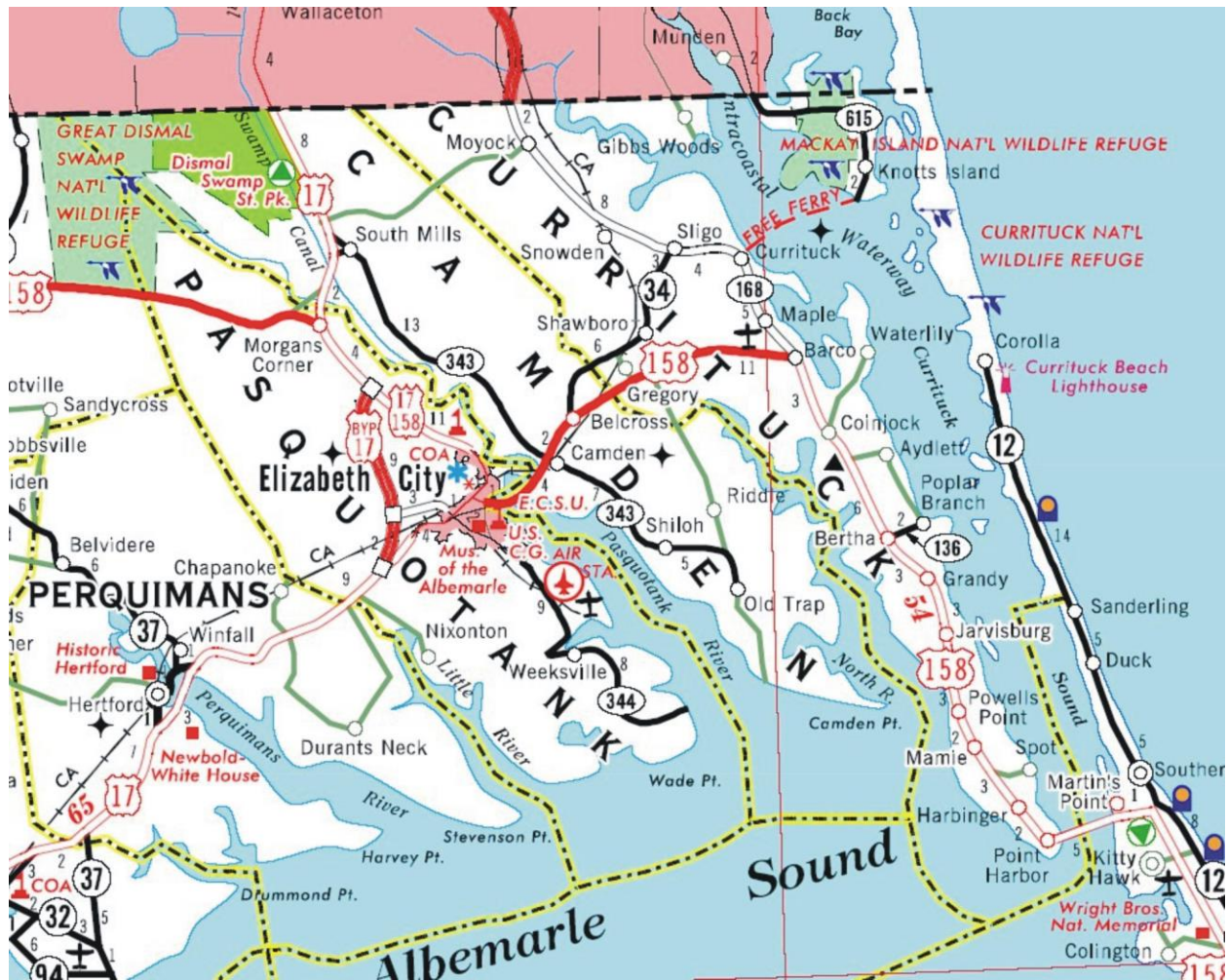

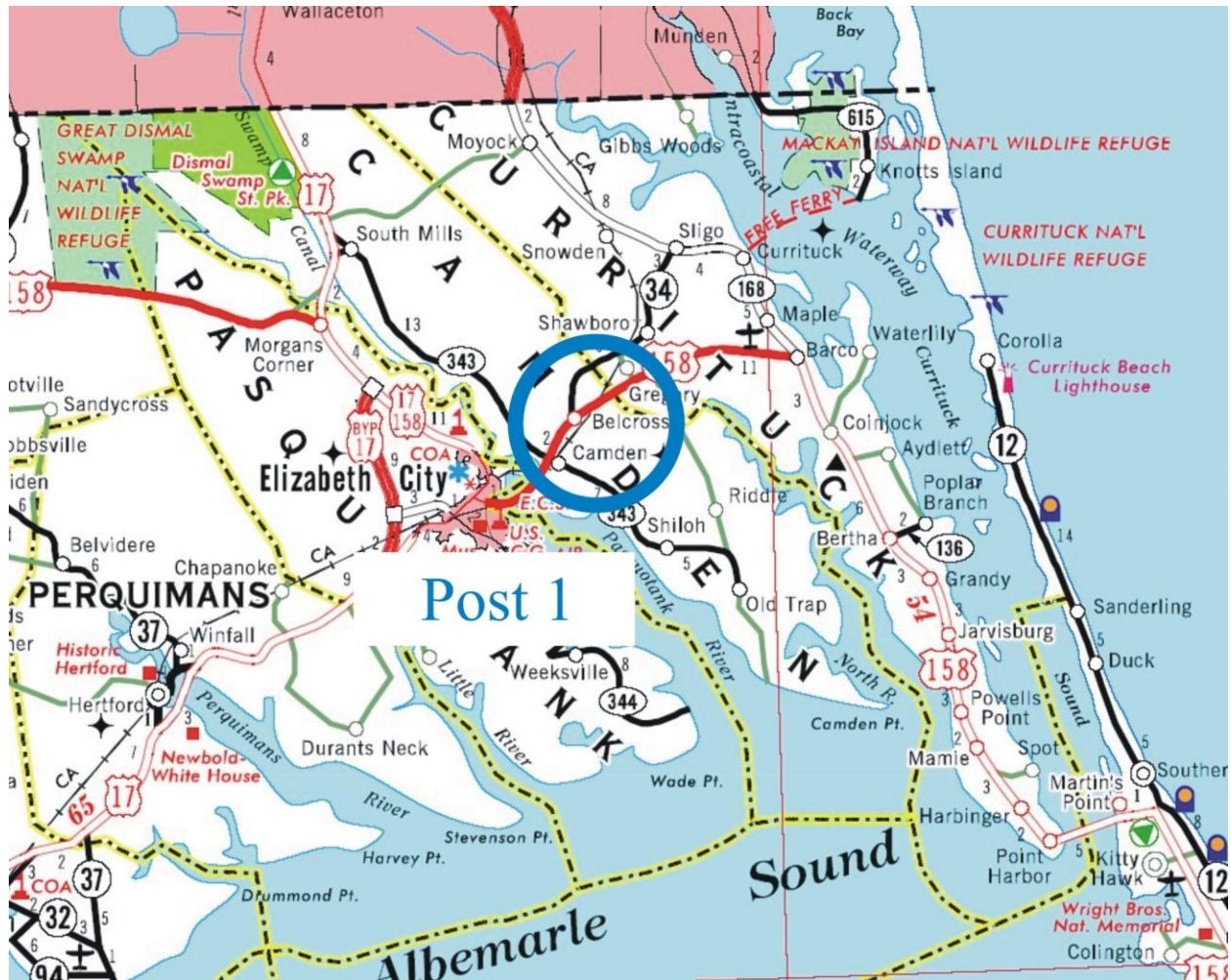

Post 1 – US158 & NC34 Belcross (1 Trooper)

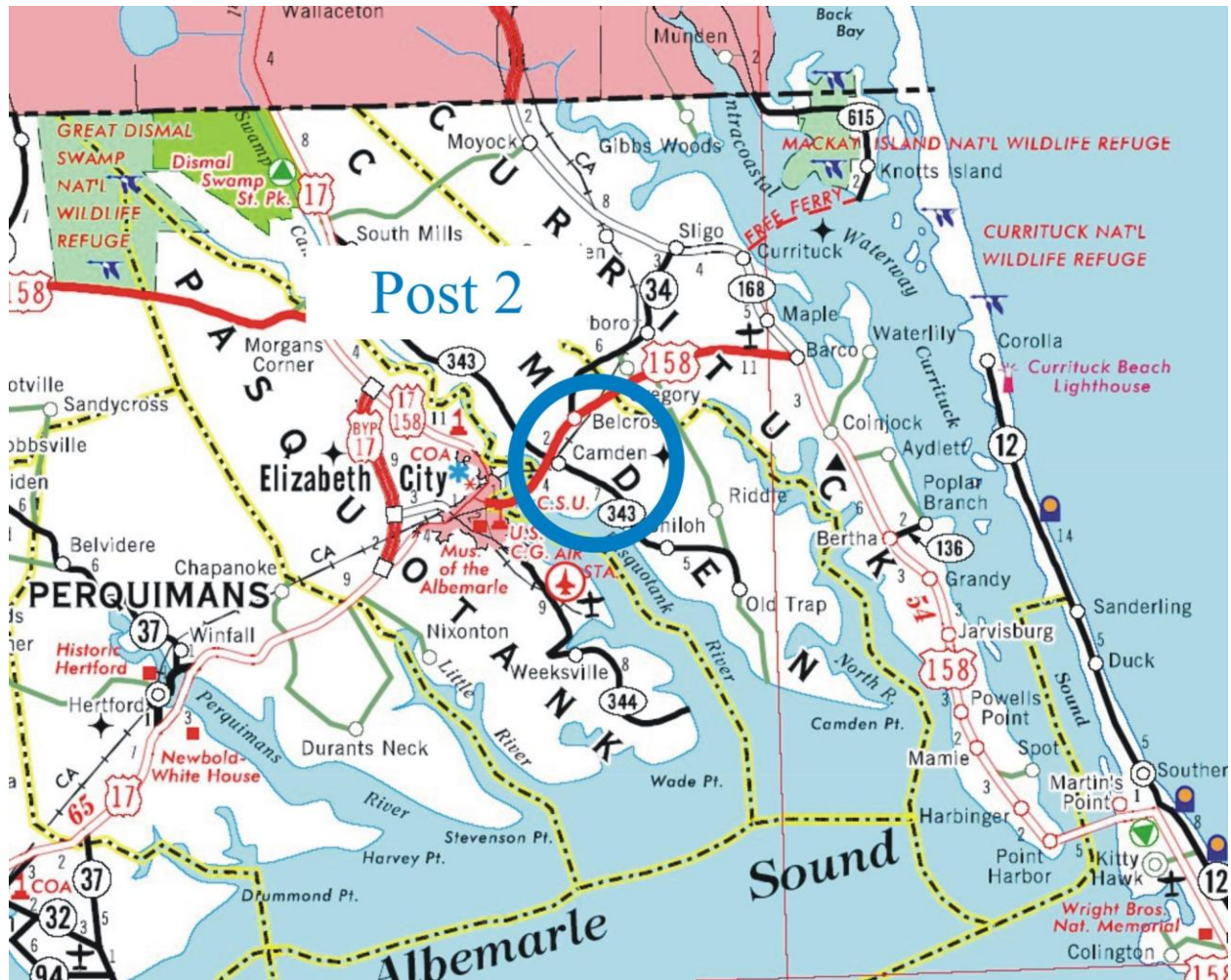
Direct traffic west on US158

Post 2 – US158 & NC343 Camden (3 Troopers)

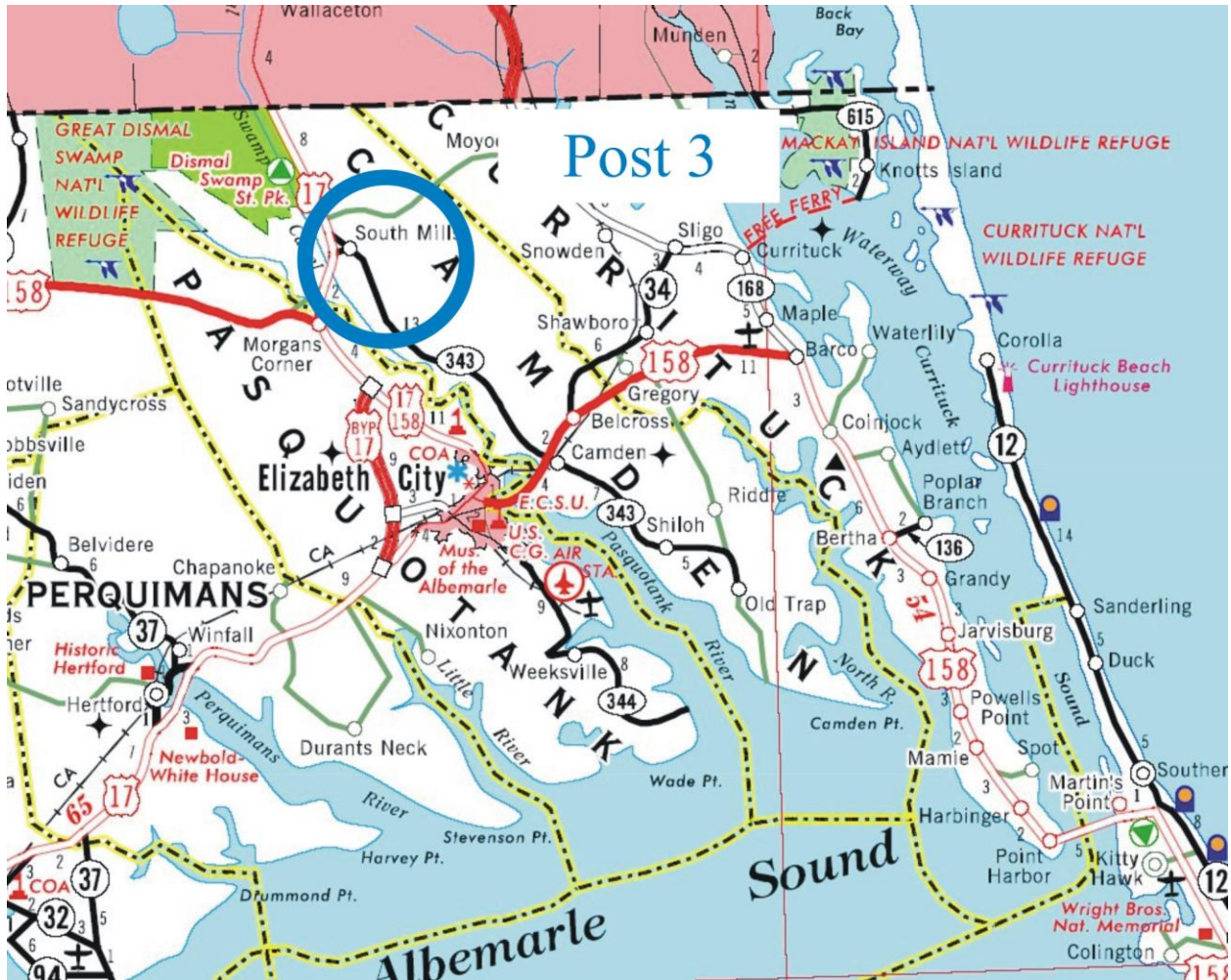
Traffic Light – Direct traffic north on NC343

Post 3 – NC343 & US17 Business South Mills (2 Troopers)

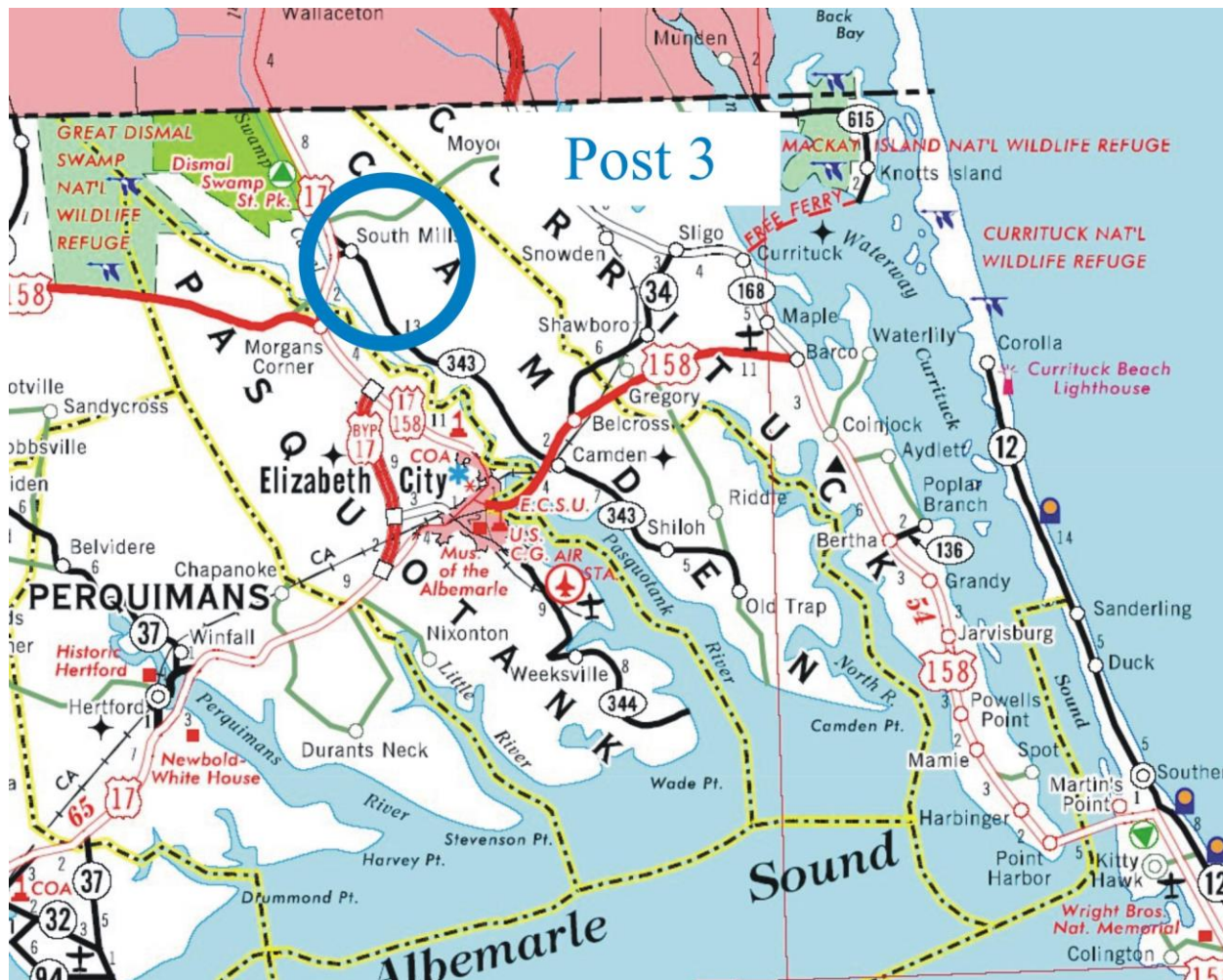
Keep all traffic moving north on NC343 to US17 Bypass. Block all traffic from turning south on US17 Business (Main Street) in South Mills.
