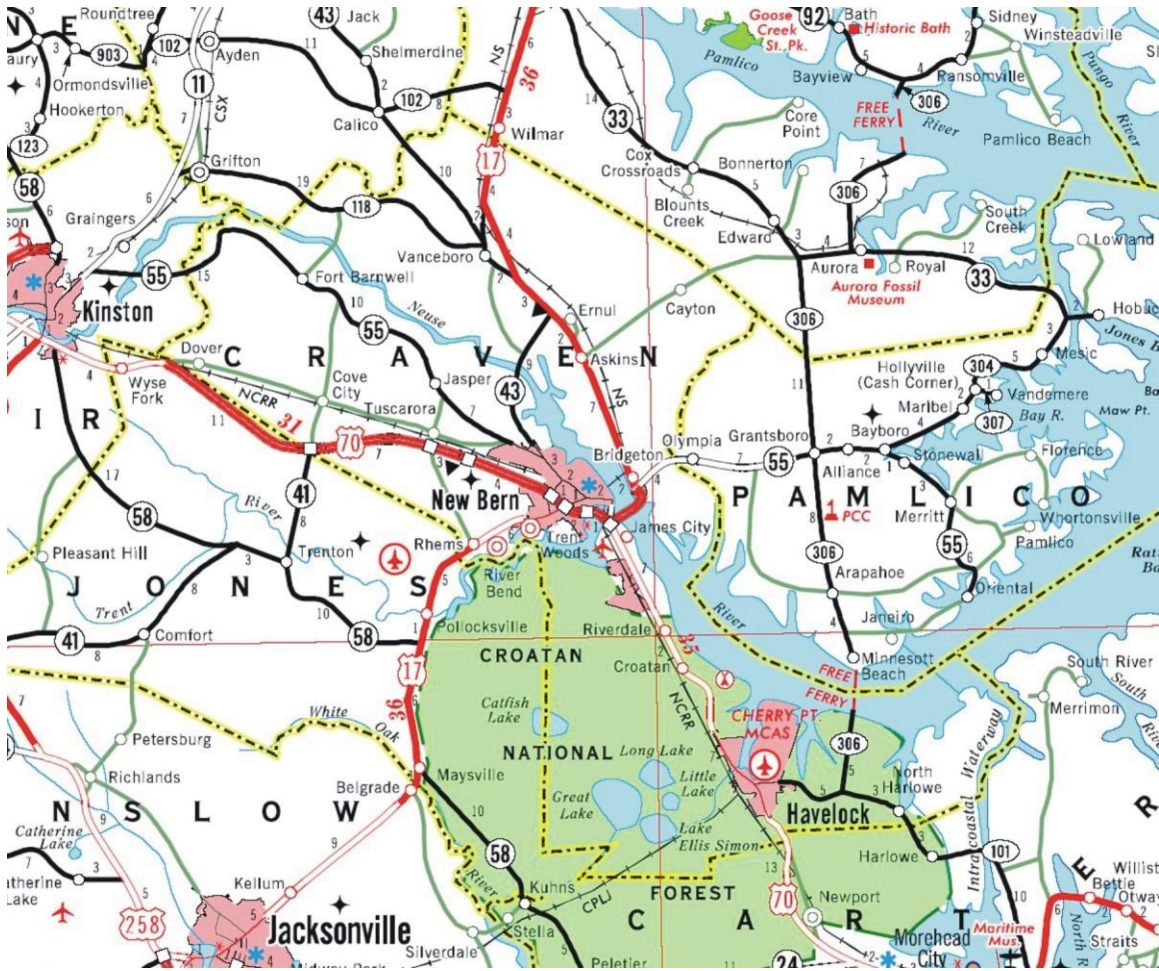

A-6 Fuel Needs

- Fuel may be obtained at the Troop A, District 6 Office.
- In the event power is lost at the District Office, fuel may be obtained at the Department of Transportation Facility on Glenburnie Road in New Bern
- In an emergency situation where fuel cannot be obtained at either of the aforementioned locations, fuel may be obtained commercially by using the Voyager Fleet Card, which will be in the possession of a District Supervisor.

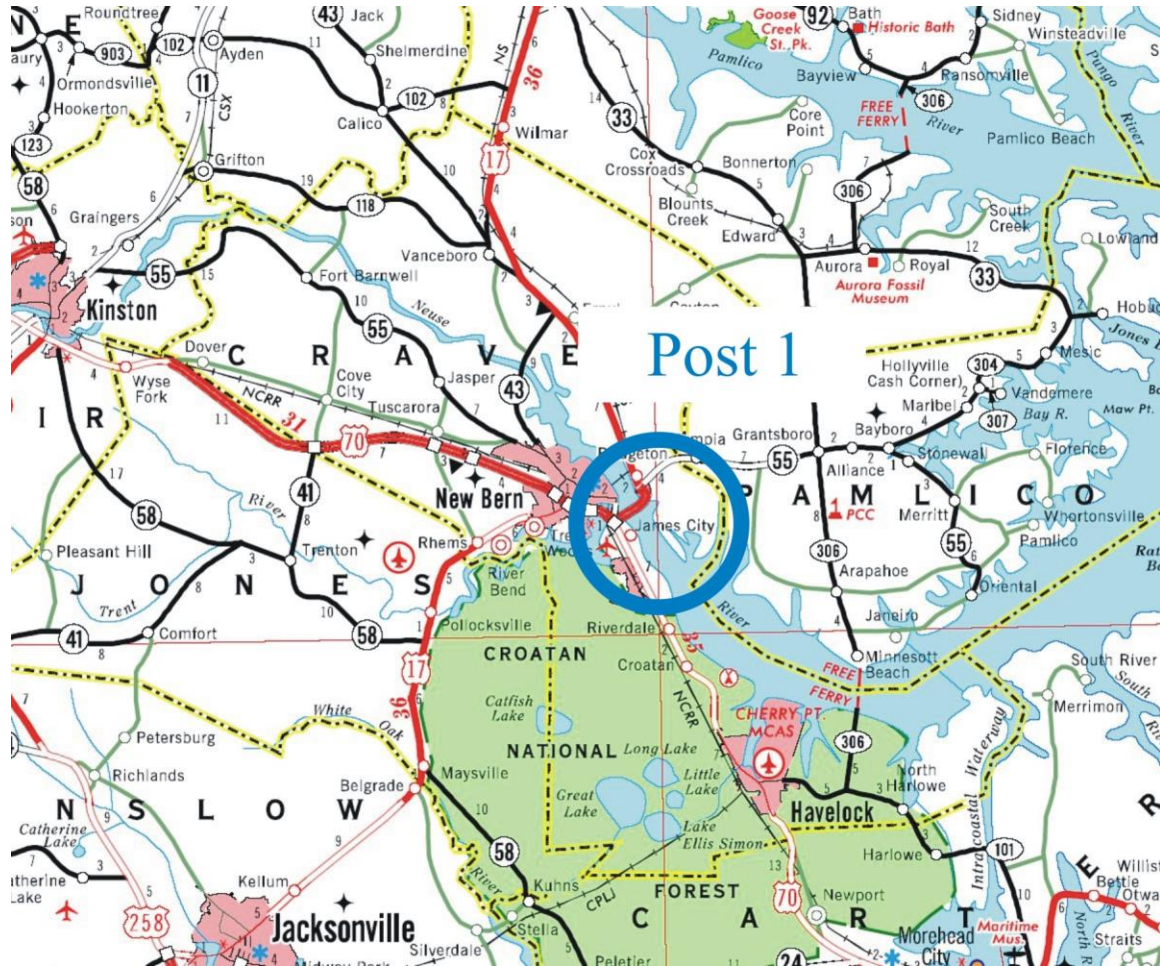

Post 1 – US70 & RP1167 – James City (4 Troopers)

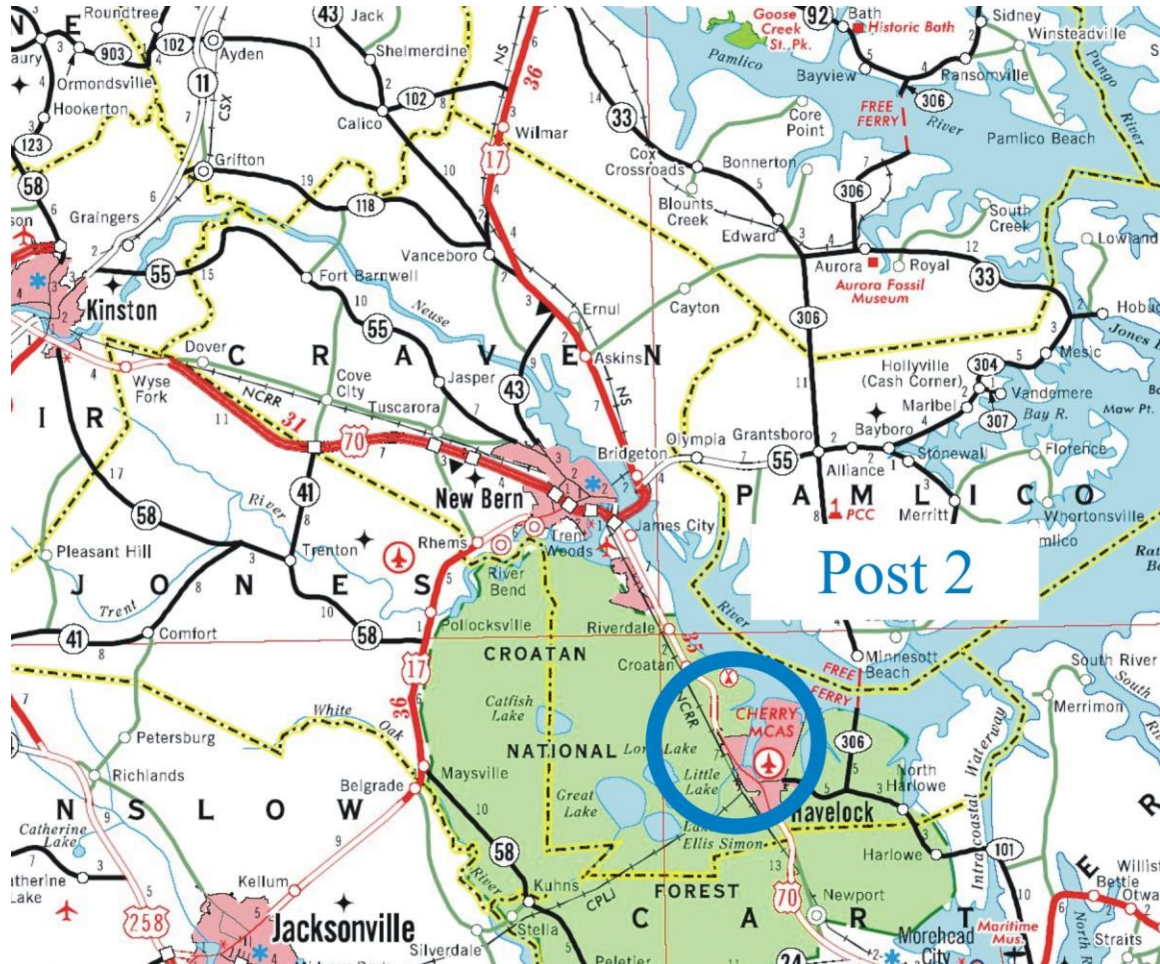
Traffic Light – Direct traffic west on US70

Post 2 – US70 & NC101 – Havelock (4 Troopers)

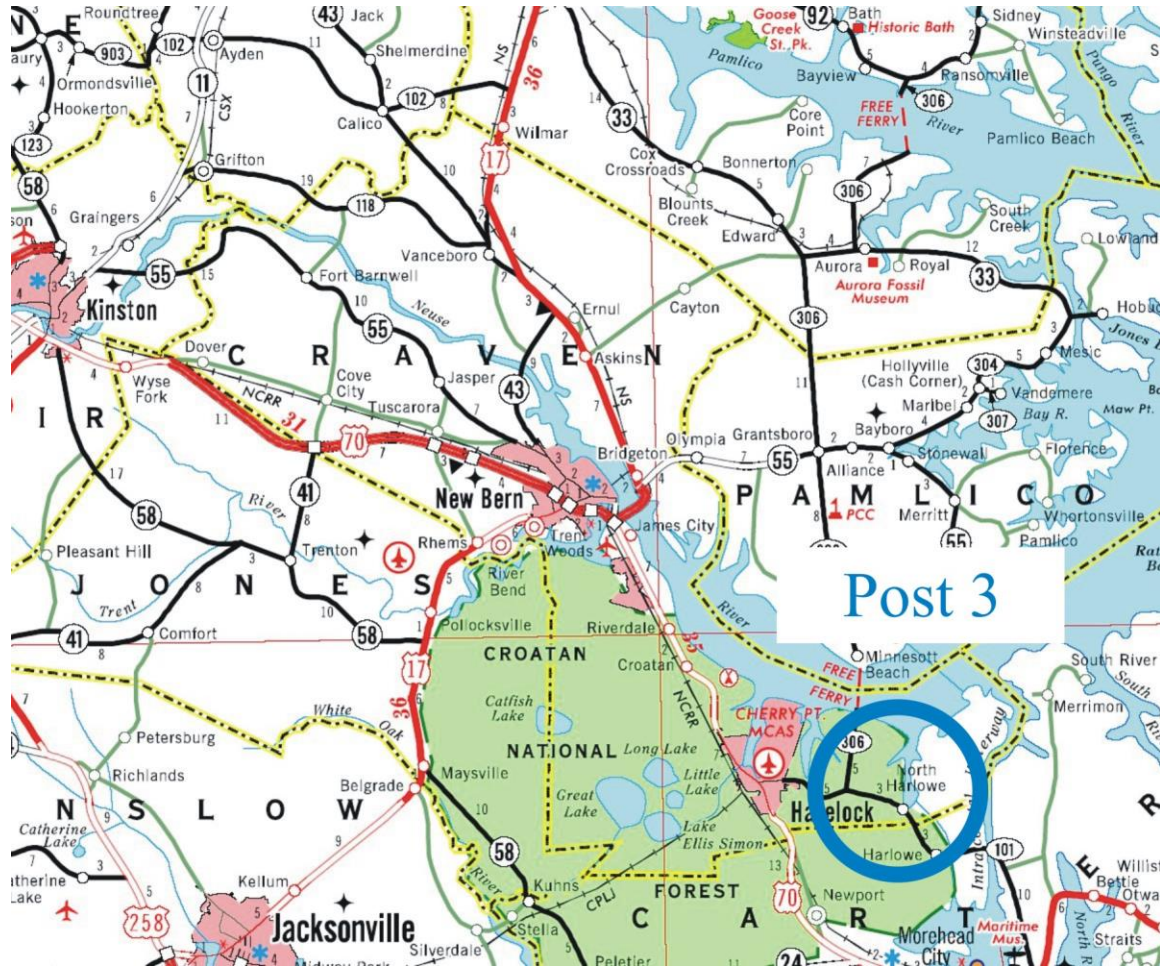
Traffic Light – Direct traffic west on US70

Post 3 – NC101 & RP1700 – Harlowe (2 Troopers)

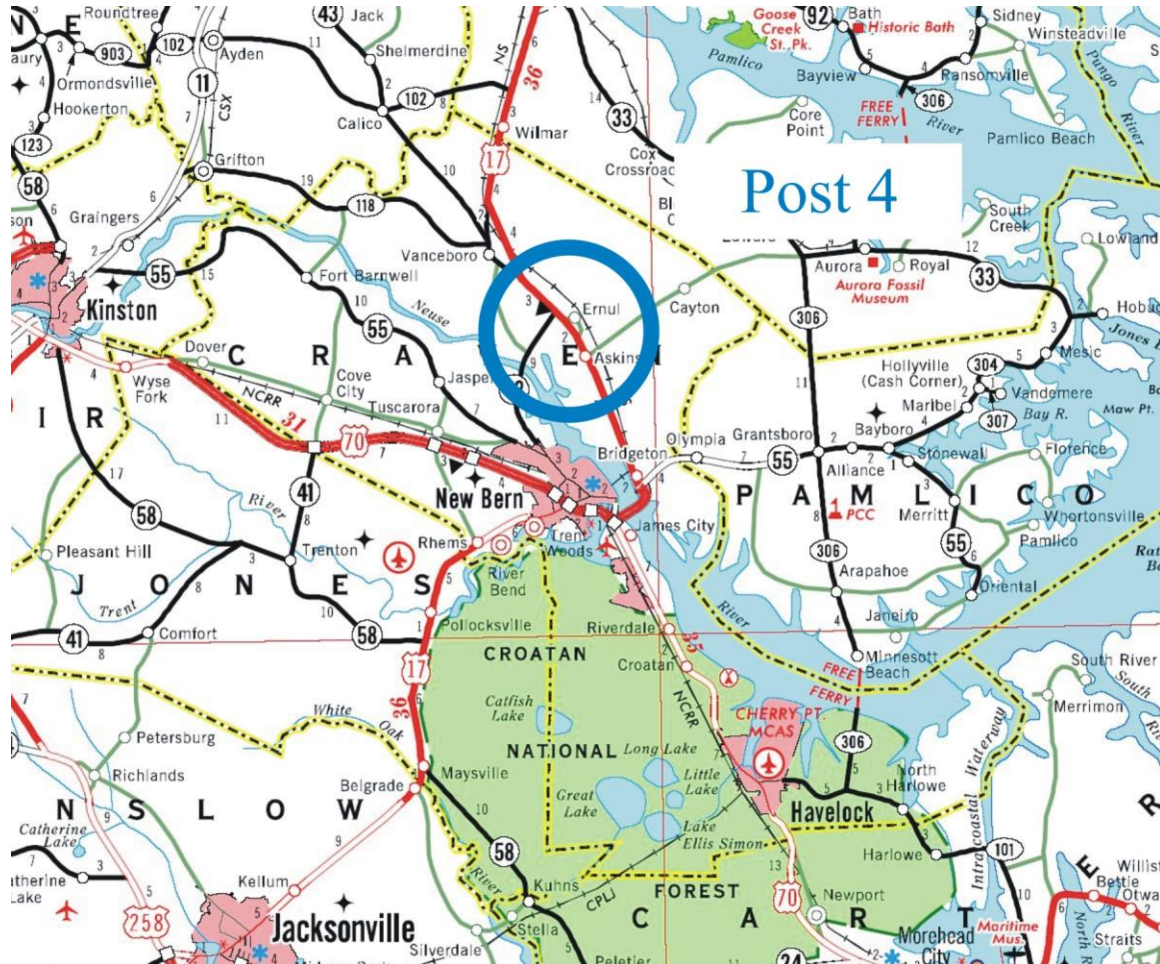
Direct traffic north on NC101

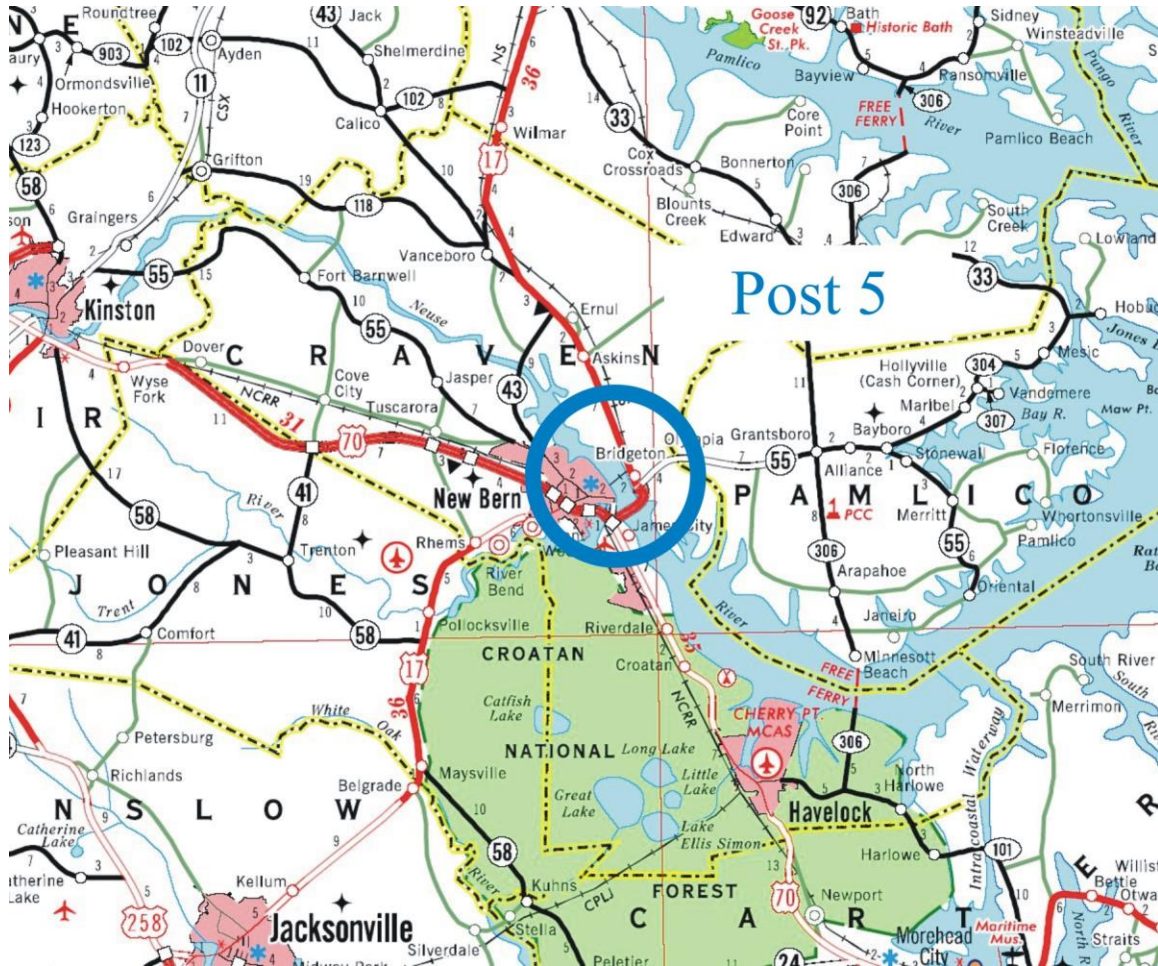
Traffic Light – Direct traffic south on US17
