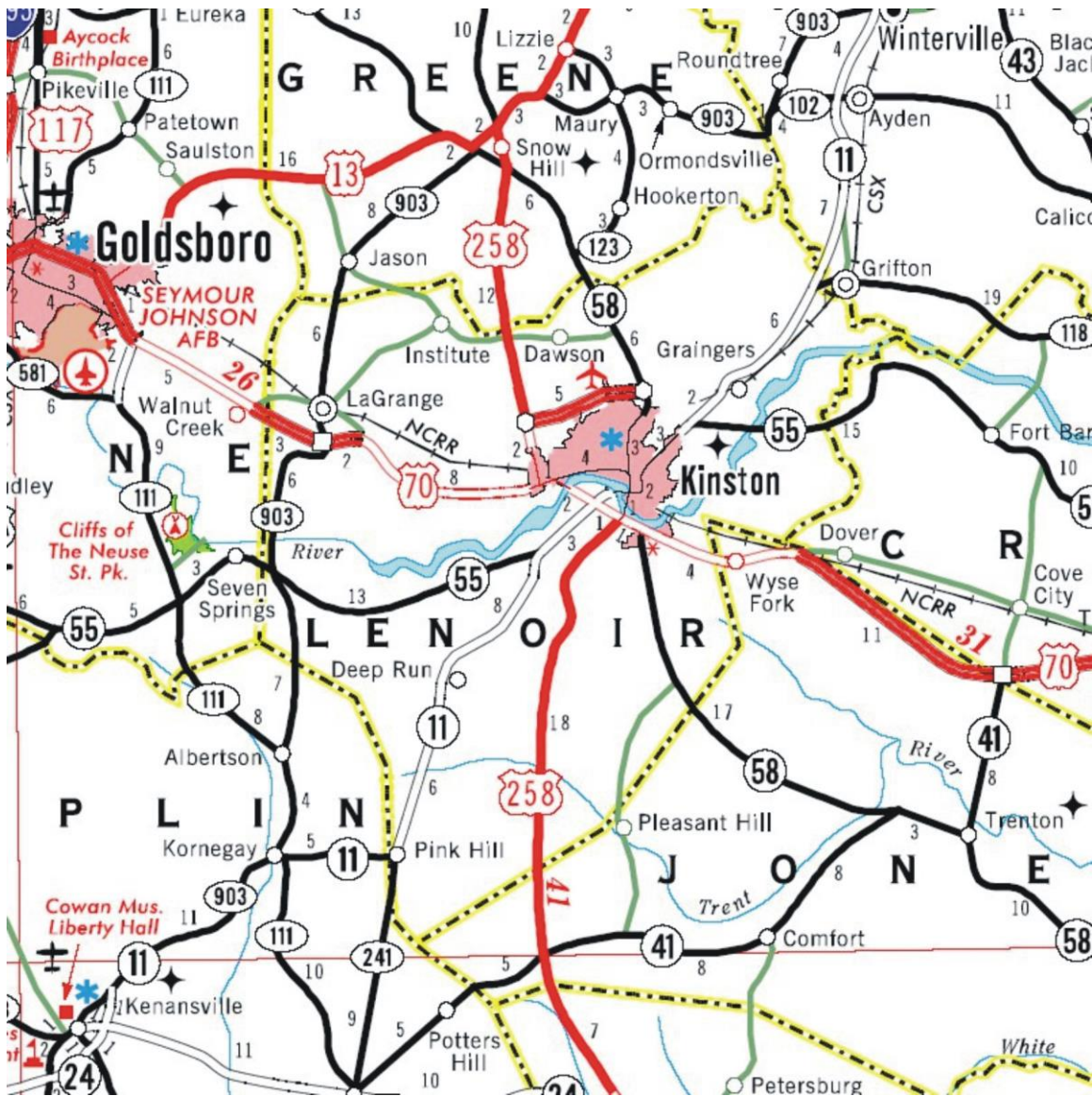

A-7 Fuel Needs

- Fuel may be obtained at the Troop A, District 7 Office.
- In the event the power is lost at the District Office, fuel may be obtained at the following locations for each County: Lenoir Department of Transportation Facility on US 258 South, Kinston; Caswell Center on Vernon Avenue, Kinston
- In an emergency situation where fuel cannot be obtained at either of the aforementioned locations, fuel may be obtained commercially, if available, by using the Voyager Fleet Card, which will be in the possession of a District Supervisor.

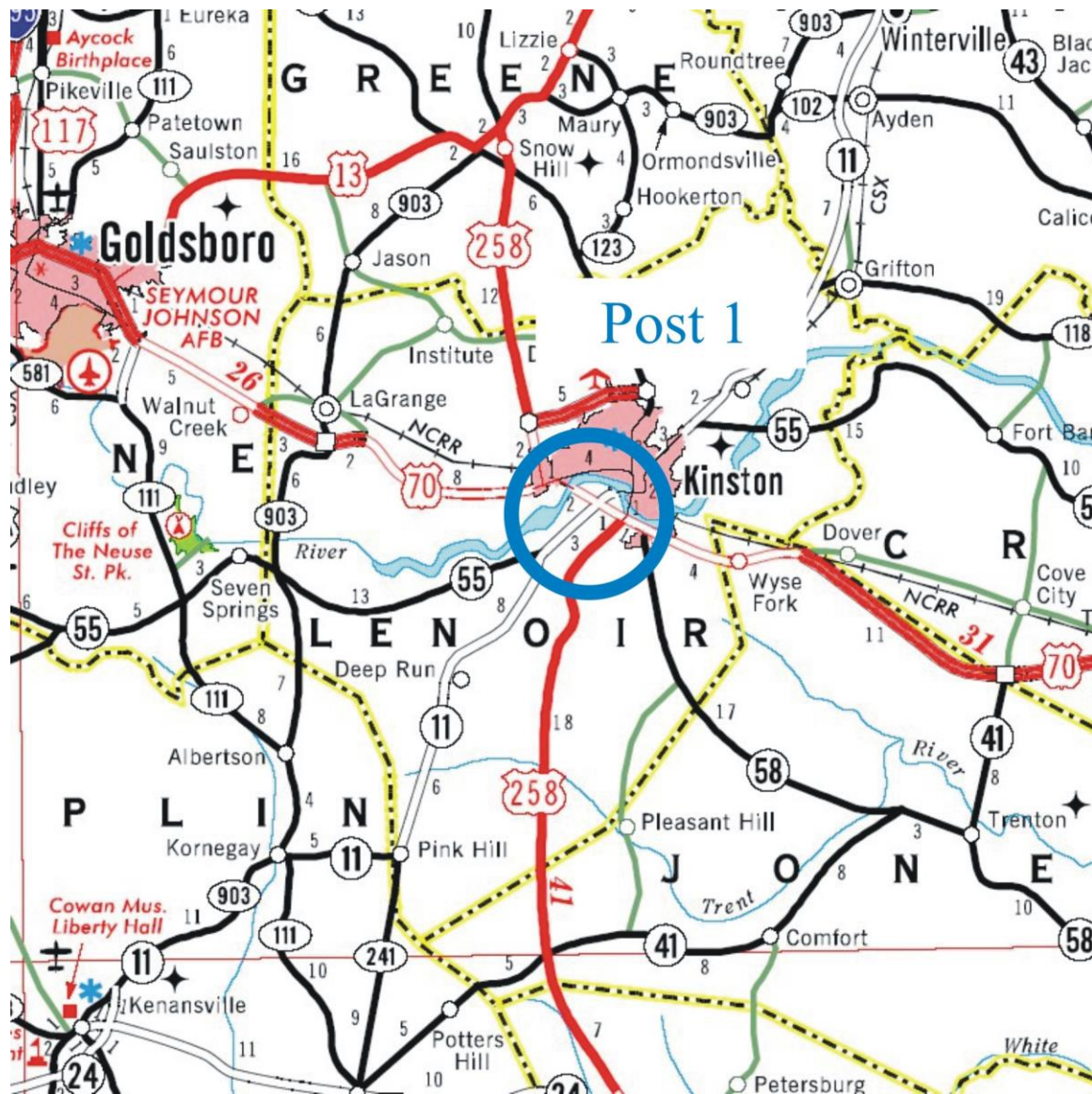

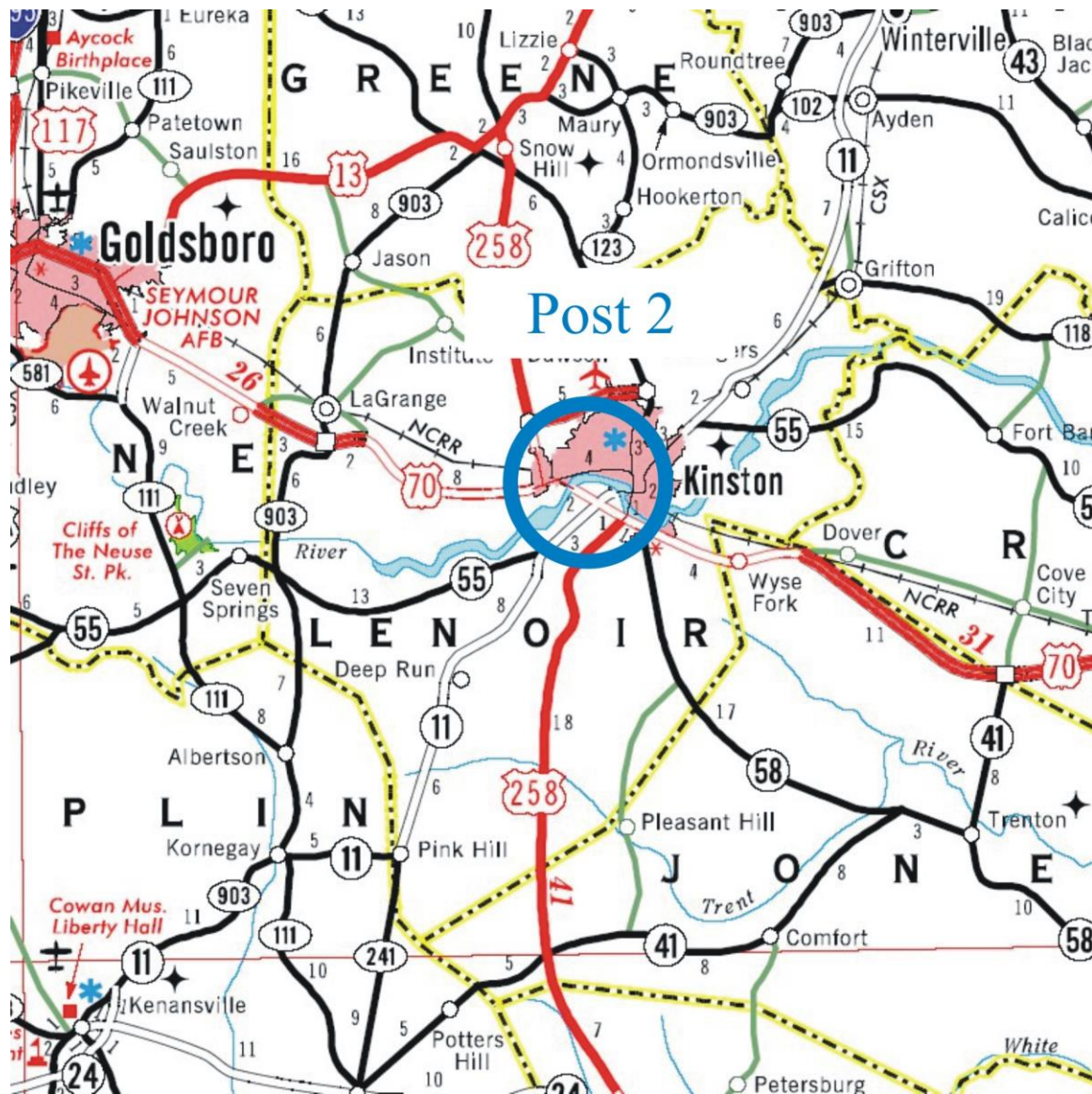
Traffic Lights – Direct traffic west on US70

Post 2 – US70 & RP1548 – Kinston (2 Troopers)

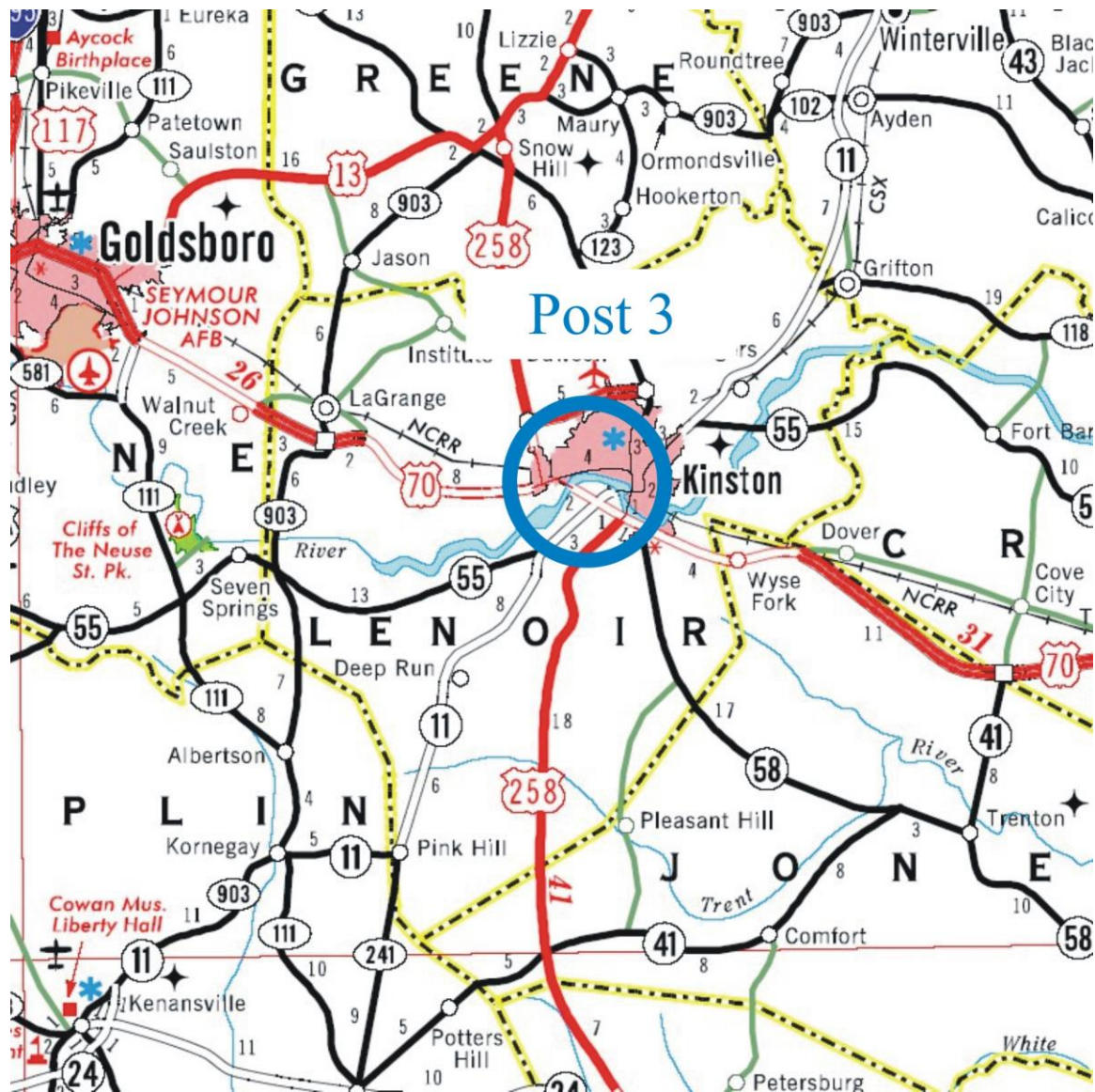
Traffic Light – Direct traffic west on US70
