Asking for Contributions?

Many of our subrecipients may seek contributions from individuals, businesses and foundations to fund their charitable work. With the increasing number of charity scams, North Carolina requires a charitable solicitation license for any organization or person that intends to directly solicit contributions in North Carolina, or intends to hire a person or business to solicit contributions in North Carolina. Licenses are obtained from the Charities Division of the North Carolina Secretary of State. Licenses must be renewed each year to maintain licensed status. There are several statutory <u>exemptions</u> to this requirement within North Carolina General Statute I3IF that many of GCC's subgrantees may fall under. According to the Secretary of State, if an organization requires a license but operates without one, that organization may be subject to administrative penalties or fines in addition to civil and/or criminal prosecution. Thus, please review the exemptions to ensure that your organization does not require a license.

Employment Upon Prison Release

The Labor & Economic Analysis Division (LEAD) of NC Department of Commerce has a new online <u>Reentry</u> <u>Outcome Reporting System</u>. Employment and wage data is available by annual cohorts of individuals exiting prison back to 1997. For example, the IO-year employment rate of the cohort exiting prison in 2012 has been steady at about 34% with 2021 wages at almost \$21,000.
