

New Snapshot on COVID and Crime in NC

CJAC has released a new publication examining crime trends a year before and after Governor Cooper's March 2020 Stay-at-Home Order. Notable changes were seen in both the type and locations of reported crime. Violent crimes, such as assaults, increased in residences, while residential property crimes saw a decrease.



<u>New Justice Data Portal Dashboard Released – Traffic Stops by County</u>

You can now view traffic stop data by county with a new interactive dashboard on the North Carolina Justice Data Portal. Selections can be made to view traffic stops by reason for stop, such as speeding or suspected DUI; citations written versus warnings issued; as well as the types of searches conducted during traffic stops and if those searches resulted in finding contraband. The dashboard displays information for traffic stops conducted over the last 5 years and is updated with new data every quarter. Demographic information including race/ethnicity and gender are also included.

Attention Law Enforcement Applicants/Grantees!

The Traffic Reporting Statute NCGS §143B-903 requires that most state and local law enforcement agencies report data on traffic stops within 60 days to the SBI. A list of agencies required to report each year is available on the SBI website. Any agency that does not submit this data as required "shall be ineligible to receive any law enforcement grants available by or through the state." Ensure your agency is in compliance with this requirement to prevent a hold on grant funds.

GEMS is Retiring!

GCC Subrecipients have used GEMS (Grants Enterprise Management System) to apply for and administer grants with GCC since 2012. After many years of faithful service, it's time for GEMS to retire. GCC will be migrating to the NC EBS (Enterprise Business Services) platform later this fall. As we approach that time, GCC will provide more information and training. Several other state agencies use this system to manage large grant programs. Keep looking for information in The GIST, and watch out for additional emails from GCC for information on migrating your current Projects to EBS and training in the new system. Please join us in thanking GEMS for II+ years of hard work. We hear that GEMS is planning to retire to the Outer Banks and spend the rest of its days in the sun and waves!

In April, Courtney Banks-McLaughlin joined the CJI committee.


