#### **Juvenile Justice Update**

William L. Lassiter, Deputy Secretary for Juvenile Justice

- Overview of: Juvenile Justice as a Division and related transition, gun violence reduction efforts, the Task Force for Safer Schools.
- Since reopening schools in August of 2021, the number of school-based complaints has rebounded consistent with 2019 trends seen prior to both the pandemic and Raise the Age implementation.
- There have been 5 vulnerable juveniles and 3 care review teams since implementing S207 on December 1, 2021.

# **2022 Juvenile Age Report Contents**

Kimberly Quintus, Juvenile Justice

- The January 15<sup>th</sup> report is statutorily required and must address updates on planning steps completed, as well as legislative, administrative, and funding recommendations each year.
