GCC has standard procedures for submitting reimbursements for payment in the Grants Enterprise Management System. If the procedures are not properly followed, reimbursements may have to be returned to the subrecipient for modifications.

Bookmark the <u>GCC Grant Management Guidelines</u> and include all required documents to expedite approval of your request. Here are a few reasons that reimbursements are returned to subrecipients for modifications:
