LAWS AND RULES COMMITTEE REPORT

Vice Chairman Steve Johnson presented the Law and Rules Committee report. Vice-Chairman Steve Johnson, Debra Duncan, Kim Heffney, Jerry Pitman and Tamara Rabenold met on June 15, 2022, from 2:30 P.M. to 3:00 P.M. The Committee discussed several items: First, the Committee discussed the status of the Board's pending bill. Vice-Chairman Steve Johnson stated that the bill has not yet been heard in the House, but he is optimistic it will pass before adjournment. The committee also reviewed and discussed rules changes to 14B NCAC 16 .0904 (a)(4) and 14B NCAC 16 .0707 (c)(4). The Committee recommended that Attorney Gray submit a proposed draft to the August Committee meeting for approval, then the full Board meeting.

DEBRA DUNCAN MADE A MOTIONED TO ACCEPT THE LAWS AND RULES REPORT. KIM HEFFNEY SECONDED THE MOTION. MOTION CARRIED. NONE OPPOSED.

TRAINING AND EDUCATION COMMITTEE REPORT

Vice-Chairman Steve Johnson presented the Training and Education report. On June 15, 2022, the Training and Education Committee met from 1:00 P.M. to 1:30 P.M. Vice-Chairman Steve Johnson, Stacy Buff, Tamara Rabenold, Assata Buffaloe and Sam Russell were present. Training Investigator Ray Bullard presented the trainer courses delivered in 2022 and the course schedule for 2022-2023. Investigator Bullard's report also included information from two reported accidental weapon discharges. The Committee discussed several topics: First, the Committee discussed the interpretation of Guard Dog Service Profession license. If the dog is only used for protection, this is a Security Guard & Patrol function, but if a dog is used for a specific task such as bomb detection, drug detection, etc., this would require a Guard Dog license. Second, Vice-Chairman Steve Johnson stated that Director Sherwin submitted a list of organizations that provide conferences and seminars for continue education credits for standing approval. The Committee discussed and approved the list, and hope that it will help to streamline the renewal process. Also, the Committee reviewed and approved sixteen (16) applications for continuing education credits. Lastly, the Committee discussed and approved a grant application from Central Piedmont Community College.

The Committee deferred the discussion on changing 14B NCAC 16 .0707 to the Laws and Rules Committee.

Director Sherwin reminded the industry members that the Board is currently accepting grant applications for both industry training and the Community College Scholarship program. The applications can be found on the PPS website and are accepted throughout the year.
