LEGISLATIVE UPDATE

The House placed its cell phone bill (HB87) into their budget, which was released on May 19th. This means that both the House and Senate have placed their chamber's bill into their respective budgets.

House Bill 959 was amended to include a "Regulation of wireless communication devices."
