Juvenile Justice Funds Awarded

We are excited to announce that the GCC Juvenile Justice team has been awarded FY2021 funds from the Office of Juvenile Justice and Delinquency Prevention's Title II Part B Formula Grants program. Circumstances at the federal level have kept Title II funds on hold for all states across the country. With these awards the JJ team can now provide GCC 2022 Juvenile Justice Committee determination letters for approved subrecipient projects. We look forward to continuing to support services for justice-involved and at-risk youth across North Carolina.



SBI/Local Law Enforcement Tackle Cold Case Backlog

The North Carolina State Bureau of Investigation is becoming increasingly focused on leveraging cold case investigative practices to assist local law enforcement agency partners with unsolved cases. In addition to using SBI investigative assets, a GCC grant has enabled the SBI to add additional capacity and to engage outside consulting assistance using DNA. Early investments have demonstrated positive results as highlighted by several cold case success stories. SBI leaders believe there is significant long-term potential and public safety benefit of this program. These efforts promise to bring justice and closure to the victims of long-unsolved serious crimes including homicides and sexual assaults. [Read more.](#)

Do You Have a Project Ending Sept. 30?

GCC Grant Management Guidelines, Closing Awards is an essential resource. Important reminders:

- Begin the closeout process as soon as the project is completed.
- Closeout can be initiated prior to the performance period end date.
- Final reimbursement requests must be marked 'Final' and are **due 60 days after the performance period ends.**
- Note the sections in the guidelines on closeout related to refunds, funds reversion and equipment and supplies disposition.
