

- 10. Private property debris removal (right of entry work) upon private property, if authorized by FEMA, will be done according to the rates listed herein. Vendor shall engage in PPDR work only with a written right of entry (See Right of Entry Approval Form, Attachment L) and hold harmless document executed by the private property owner and upon the written approval of the Activating Entity.
